I N F O R M A T I O N

The defendant having waived in open court prosecution by indictment, the Acting United States Attorney for the District of New Jersey charges:

COUNT ONE

(Felon in Possession of a Firearm)

On or about March 6, 2021, in Hudson County, in the District of New Jersey and elsewhere, the defendant,

RAHEEM ALLEN,

knowing he had previously been convicted in a court of at least one crime punishable by a term of imprisonment exceeding one year, did knowingly possess in and affecting commerce a firearm, namely an Intratec Tec-22 semi-automatic firearm, bearing serial number 063131, loaded with twenty-five rounds of .22 caliber ammunition.

In violation of Title 18, United States Code, Section 922(g)(1).

COUNT TWO

(Possession with Intent to Distribute Cocaine)

On or about March 6, 2021, in Hudson County, in the District of New Jersey and elsewhere, the defendant,

RAHEEM ALLEN,

did knowingly and intentionally possess with intent to distribute a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance.

In violation of Title 21, United States Code, Sections 841(a)(1) and (b)(1)(C).

FORFEITURE ALLEGATION AS TO COUNT ONE

Pursuant to Title 18, United States Code, Sections 924(d), and Title 28, United States Code, Section 2461(c), upon conviction of the firearms offense alleged in Count One of this Information, the defendant,

RAHEEM ALLEN,

shall forfeit to the United States any firearms and ammunition involved in or used in the commission of such offense, including:

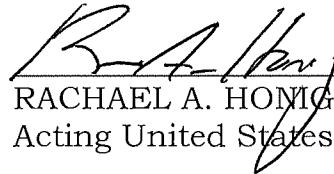
- (1) One Intratec Tec-22 semi-automatic firearm, bearing serial number 063131;
- (2) Twenty-five rounds of .22 caliber ammunition; and
- (3) Three boxes of .22 caliber ammunition.

FORFEITURE ALLEGATION AS TO COUNT TWO

Pursuant to Title 21, United States Code, Section 853, upon conviction of the controlled substance offense in Count Two of this Information, the defendant,

RAHEEM ALLEN,

shall forfeit to the United States any and all property constituting or derived from any proceeds the defendant obtained directly or indirectly as a result of violating Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C), and any property used or intended to be used in any manner or part to commit and to facilitate the commission of the offense alleged in Count Two of this Information
