charges:

On or about April 17, 2019, in Essex County, in the District of New Jersey
and elsewhere, the defendant,


TYSON FLETCHER,

having been convicted of a crime punishable by imprisonment for a term
exceeding one year in the New Jersey Superior Court for Essex County,
possessed in and affecting commerce a firearm, namely, a black .380 caliber
Taurus PT738 handgun bearing serial number 06154F loaded with five hollow-
point bullets, and did so knowingly.

In violation of Title 18, United States Code, Section 922(g)(1).

1. The allegations contained on Page One of this Indictment are incorporated by reference as though set forth in full herein for the purpose of alleging forfeitures pursuant to Title 18, United States Code, Section 924(d)(1), and Title 28, United States Code, Section 2461(c).

2. As the result of committing the firearms offense alleged in this Indictment, the defendant,

TYSON FLETCHER,

shall forfeit to the United States, pursuant to Title 18, United States Code, Section 924(d)(1), and Title 28, United States Code, Section 2461(c), any firearm and ammunition involved in or used in the commission of such offense, including, but not limited to, the following:

- (1) one .380 caliber Taurus PT738 handgun bearing serial number 06154F; and
- (2) five rounds of hollow-point ammunition.
