### COUNT ONE

(Receipt of Child Pornography)

From on or about November 26, 2021 through on or about March 26, 2022, in Union County, in the District of New Jersey, and elsewhere, the defendant,

### ROBERT H. CONRAD,

did knowingly receive child pornography, as defined in Title 18, United States Code, Section 2256(8), that had been mailed, and using any means and facility of interstate and foreign commerce, shipped, and transported in and affecting interstate and foreign commerce by any means, including by computer.

In violation of Title 18, United States Code, Section 2252A(a)(2)(A) and Section 2.

#### COUNT TWO

## (Distribution of Child Pornography)

From on or about November 26, 2021 through on or about March 26, 2022, in Union County, in the District of New Jersey, and elsewhere, the defendant,

#### ROBERT H. CONRAD,

did knowingly distribute child pornography, as defined in Title 18, United States Code, Section 2256(8), using any means and facility of interstate and foreign commerce and that had been mailed, and had been shipped and transported in and affecting interstate and foreign commerce by any means, including by computer.

In violation of Title 18, United States Code, Section 2252A(a)(2)(A).

### ATTACHMENT B

I, Bradley J. Benwell, am a Special Agent with the Department of Homeland Security, Homeland Security Investigations ("HSI"). I am fully familiar with the facts set forth herein based on my own investigation, my discussions with other law enforcement officers, and my review of reports, documents, and other items of evidence. Where statements of others are related herein, they are related in substance and in part. Because this Affidavit is being submitted for the sole purpose of establishing probable cause to support the issuance of a complaint, I have not set forth each and every fact that I know concerning this investigation. Where I assert that an event took place on a particular date, I am asserting that it took place on or about the date alleged.

## Background

1. At all times relevant to this Complaint, Defendant Robert H. Conrad ("CONRAD") was a resident of Roselle, New Jersey.

### The Investigation

From on or about November 26, 2021 through on or about March 26, 2. 2022, law enforcement conducted an undercover online session (the "2021/2022 Sessions") using a publicly available peer-to-peer ("P2P") software application program (the "P2P Program"). P2P is a method of communication available to Internet users through the use of special software. The software is designed to allow users to trade digital files through a worldwide network that is formed by linking computers together. Generally, when P2P software is installed on a computer, the user is directed to specify a "shared" folder. All files placed in that user's "shared" folder are available to anyone A person interested in sharing child on the worldwide network for download. pornography with others in the P2P network need only place those files in his or her "shared" folders. Those child pornography files are then available to all users of the P2P network for download regardless of their physical location. The computers that are linked together to form the P2P network are located throughout the world; therefore, the P2P network operates in interstate and foreign commerce.

3. The P2P Program allowed users to connect to and share, search and download content. The version used by law enforcement allows law enforcement to determine the IP address through which target computers access the Internet.

4. During the 2021/2022 Sessions, a computer user shared multiple files of child pornography using the P2P Program from a certain IP address (the "Target IP Address"). The undercover law enforcement officer established a direct connection to the Target IP Address. Several of the files being shared by the Target IP Address had a hash value that has been identified to contain visual depictions of children engaged in sexual acts with adults. These files were shared during the 2021/2022 Sessions by a device using the Target IP Address. Video files and images of child pornography were

available from the Target IP Address, which other users accessing the P2P Network could download.

5. Indeed, during the 2021/2022 Sessions, more than 175 media files containing child pornography were available from the Target IP Address. The files included multiple visual depictions of pre-pubescent children engaged in sexual acts with adults, including the following representative sample:

6. The Target IP Address was assigned, at the approximate times of the 2021/2022 Sessions, to an account registered to CONRAD at his Roselle, New Jersey residence (the "Residence").

7. On or about June 15, 2022, law enforcement executed a search warrant at the Residence.

8. During the search of the Residence, law enforcement seized, among other things, a desktop computer located in the attic (the "Desktop Computer"), to which stories detailing sexual intercourse with underage children were saved.<sup>1</sup> After being advised of and waiving his *Miranda* rights in writing, CONRAD made a recorded statement. He told law enforcement, in sum and substance, that he had previously downloaded but had since deleted the P2P program and used the P2P Program to download and view images and videos depicting child pornography.<sup>1</sup> Conrad further explained, in sum and substance, that he understood that, by using the P2P Program to download and view images and videos depicting child pornography, he was also using the P2P program to share files containing child pornography with other P2P Program users.

9. Based upon my education, training and experience, and my discussions with other law enforcement officers, and to the best of my knowledge, the child pornography files described in Paragraph 5, traveled in interstate commerce and were produced using materials that were mailed and shipped and transported in and affecting interstate and foreign commerce by any means, including by computer, that is, the images and or videos were downloaded from and transmitted via the Internet.
