

COUNT ONE

(Travel With Intent to Engage in Illicit Sexual Conduct)

On or about October 27, 2022, in Essex County, in the District of New Jersey, and elsewhere, the defendant,

**PATRICK JOHN ANTHONY CODERRE,
a/k/a "T Ocean,"**

did travel into the United States for the purpose of engaging in illicit sexual conduct, as defined in Title 18, United States Code, Section 2423(f), with another person.

In violation of Title 18, United States Code, Section 2423(b).

ATTACHMENT B

I, Isidro Cruz, am a Special Agent with the Department of Homeland Security, Homeland Security Investigations ("HSI"). I have been personally involved in the investigation of this matter. The information contained in this criminal Complaint is based on my personal knowledge and on information obtained from other sources, including but not limited to statements made or reported by witnesses with knowledge of relevant facts and law enforcement officers. Because this affidavit is submitted for the sole purpose of establishing probable cause to support the issuance of a Complaint, I have not included each and every fact known to the Government concerning this matter. Where statements of others are set forth herein, these statements are related in substance and in part. Where I assert that an event took place on a particular date and time, I am asserting that it took place on or about the date and time alleged.

1. Since in or around March 2019, law enforcement has been investigating the defendant, Patrick John Anthony Coderre, a/k/a "T Ocean" ("CODERRE"), for child exploitation offenses. During the investigation, two undercover officers using three identities ("UC-1a," "UC-1b," and "UC-2") communicated with CODERRE via text message, email, and the messaging platform Telegram concerning CODERRE's desire for sexual encounters with young children. During this correspondence, UC-1a, UC-1b, and UC-2 purported to be members of a group of child predators who had access to young children.

2. On or about October 11, 2022, UC-1a corresponded via Telegram with the user of an account titled "T Ocean." During that exchange, UC-1a provided T Ocean with UC-1a's telephone number. Approximately 2 minutes later, UC-1a received a text from the number (289) 689-0853 (the "0853 Number"), stating, "Hey just added you." UC-1a responded, "Nice! Lets still do telegram for now though." The user of the 0853 number replied, "Agree 110%." A search of a law enforcement database subsequently revealed that the 0853 Number is linked to CODERRE in international flight records.

3. On or about October 12, 2022, UC-1a corresponded with T Ocean via Telegram. During that conversation, T Ocean sent UC-1a an image showing departure and arrival information for a flight from Toronto to Newark, New Jersey on an unspecified date.

4. From on or about October 14, 2022 through on or about October 15, 2022, UC-1b exchanged email messages with the user of the email account blueoceanskys@protonmail.com ("blueoceanskys"). UC-1b asked what blueoceanskys' intentions were for his proposed trip from Canada to the United States, and blueoceanskys responded, "I'm . . . going to meet the littles that will be there and partake in the sexual festivities that unfold with them." From my training and experience, I know that child predators use the term "littles" to refer

to minor children.

5. On or about October 17, 2022, UC-1b again exchanged emails with blueoceanskys. During that exchange, UC-1b sent blueoceanskys photographs purporting to depict a minor female child called "Brittany" who supposedly would be present at a hotel-room gathering when blueoceanskys arrived in the United States from Canada:

UC-1b: as promised. That is my little girl Brittany. . . . me and Britt will def be going.

blueoceanskys: She's absolutely stunning and looking forward to meeting with you both. . . . I don't know what you all are into with her or her experience level. . . . I did send a couple things to [UC-1b] that can be enjoyed with them.

From the pic. It definitely looks like she makes a pair of jeans look good with the right fit. And would definitely do a bikini with style.

UC-1b: haha. she wear anything you put on like a doll. she is starting to fill out her outfits too much 4 my tastes. if she look too big i am sorry. Brittany's blossoms are already showing at 11 year old. very regretfully she will be 12yo in december. very sad. She still ripe. do u have little friends.

blueoceanskys: They do get older so she is learning to shave is essential. There is always waxing. And assume she got full on buds now with what you said. But no need to apologize. Seeing her today was a great distraction. Her development didn't show in the pics.

I seem to live in the land of the ultra there were two moms that came out with their true desires for their little girls. Yes both still flat and bald. One got ultra cold feet. The other who was still breast feeding her 8 yo yes I'm not kidding. . . .

It is a difficult subject to approach, and it's always been a back door channel through lifestyle. A.k.a the DLG lifestyle, From past experience they seem to be about the most open minded. And everyone else they always

had boys which were of zero interest to me.

. . . . Back to you and yours. She would be fun to take to a water park. A combination of Waterpark fun mixed with going back to the hotel room helping her shower and get cleaned up and thoroughly enjoying her. How long has she been fully active for?

From my training and experience, I know that “DLG” is common slang used by child predators to mean “Daddy’s Little Girl,” and the term “active” is used to mean active engagement in sexual activities between adults and children.

6. On or about October 19, 2022, blueoceanskys emailed UC-2 an order confirmation for items including “BOOTY SPARKS SILICONE LED PLUG VIBRATING SMALL” and “BOOTY SPARKS LIGHT UP SMALL ANAL PLUG.” The order confirmation listed a billing address of “Patrick Coderre, 83 Robinhood Drive, Dundas, ON L9H 4G2, Canada,” and listed the 0853 Number as the associated telephone number.

7. On or about October 20, 2022, UC-1a corresponded on Telegram with T Ocean. During that exchange, T Ocean stated that he was trying to send a yoga ball to UC-1a. T Ocean then sent UC-1a an image of a purple yoga ball with two phallic objects affixed to it. T Ocean also stated that he planned to arrive in the United States on October 27, 2022.

8. On or about October 21, 2022, UC-2 corresponded on Telegram with T Ocean. During that correspondence, UC-2 and T Ocean discussed minor female children who would join them in a hotel room when T Ocean traveled from Canada to the United States:

UC-2: These girls are going to think it’s their 12th bday with all of these “toys” they are getting

T Ocean: Lol. Can’t wait for them to play with the new toys

And well I’m sure you will enjoy putting ash on the ball during weekend football.

Halftime entertainment.

9. At approximately 12:25 p.m. on or about October 27, 2022, UC-1a received a text message from the 8053 Number, stating: “I need the full name and address of the hotel were going to.” UC-1a then received a call from the 8053 Number. The caller again asked UC-1a for hotel information. UC-1a replied that

he would send the information via text message.

10. From approximately 12:26 p.m. to approximately 12:30 p.m. on or about October 27, 2022, UC-1a and the 8053 Number exchanged the following series of text messages:

UC-1a: [Hotel address]
Kool? Call me if anything.

8053 Number: Need zip and phone

UC-1a: [ZIP code and telephone number of hotel]
Good?

8053 Number: Hope so
They want every dam detail

11. At approximately 4:15 p.m. on or about October 27, 2022, CODERRE entered the Arrivals area of Newark International Airport and was arrested by law enforcement.
