<u>COUNT ONE</u> (Possession of a Firearm by a Convicted Felon)

The Grand Jury in and for the District of New Jersey, sitting at

Newark, charges:

On or about December 29, 2015, in Union County, in the District

of New Jersey, and elsewhere, the defendant,

DANIEL BIGELOW,

having been convicted of a crime punishable by imprisonment for a term

exceeding one year in the Superior Court of New Jersey, Union County, did

knowingly possess in and affecting commerce a firearm and ammunition,

namely, a Savage Arms Stevens Model 320 .12 gauge shotgun, bearing serial

number 121613M and 24 Estate Cartridge .12 gauge rounds.

In violation of Title 18, United States Code, Section 922(g)(1).

<u>COUNT TWO</u> (Possession of a Firearm by a Convicted Felon)

The Grand Jury in and for the District of New Jersey, sitting at Newark, charges:

On or about March 31, 2016, in Union County, in the District of New Jersey, and elsewhere, the defendant,

DANIEL BIGELOW,

having been convicted of a crime punishable by imprisonment for a term exceeding one year in the Supreme Court of New York, Nassau County, did knowingly possess in and affecting commerce a firearm, namely, a Hi-Point Model C9 9 mm. pistol, bearing serial number P1659920.

In violation of Title 18, United States Code, Section 922(g)(1).

<u>COUNT THREE</u> (Possession of Firearms by a Convicted Felon)

The Grand Jury in and for the District of New Jersey, sitting at Newark, charges:

On or about April 12, 2016, in Union County, in the District of New Jersey, and elsewhere, the defendant,

DANIEL BIGELOW,

having been convicted of a crime punishable by imprisonment for a term exceeding one year in the Supreme Court of the State of New York, Nassau County, did knowingly possess in and affecting commerce firearms, namely, a Hi-Point Model 995 9 mm. rifle, bearing serial number F04358 and Smith and Wesson Model 686 .357 revolver, bearing serial number CDW4866.

In violation of Title 18, United States Code, Section 922(g)(1).

FORFEITURE ALLEGATION

1. The allegations contained in Counts One through Three of this Information are incorporated by reference as though set forth in full herein for the purpose of alleging forfeiture pursuant to Title 18, United States Code, Section 924(d)(1) and Title 28, United States Code, Section 2461(c).

2. As the result of committing the offenses alleged in Counts One through Three of this Information, the defendant,

DANIEL BIGELOW,

shall forfeit to the United States, pursuant to Title 18, United States Code Section 924(d)(1) and Title 28, United States Code, Section 2461(c), any firearm and ammunition involved in or used in the commission of such offenses, including but not limited to, the following:

- a. One Savage Arms Stevens Model 320 .12 gauge shotgun,
 bearing serial number 121613M;
- b. One Hi-Point Model C9 9 mm. pistol, bearing serial number P1659920;
- c. One Hi-Point Model 995 9 mm. rifle, bearing serial number F04358;
- d. One Smith and Wesson Model 686 .357 revolver, bearing serial number CDW4866; and

e. 24 Estate Cartridge .12 gauge rounds.
