INDICTMENT

The Grand Jury charges:

Count 1

From on or about March 13, 2020, and continuing to on or about April 7, 2023, in Doña Ana County, in the District of New Mexico, and elsewhere, the defendants, RONALDO GALINDO LOPEZ-ESCOBAR, a.k.a. "Tio Roni," JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," WHISKEY HANS LOPEZ-AMBROSIO, a.k.a. "Hands," KAREN STEFANY HERNANDEZ-VANEGAS, JUMILCA SANDIVEL HERNANDEZ-PEREZ, ELI

ADONIS ESTEBAN-LOPEZ, and WENRY GABRIEL GOMEZ-LOPEZ, unlawfully, knowingly and intentionally combined, conspired, confederated, agreed, and acted interdependently with each other and with other persons whose names are known and unknown to the Grand Jury to commit an offense defined in 8 U.S.C. §§ 1324(a)(1)(A)(ii) and (iii), specifically, transporting and harboring illegal aliens.

Manner and Means

The manner and means by which the defendants, RONALDO GALINDO LOPEZ-ESCOBAR, a.k.a. "Tio Roni," JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," WHISKEY HANS LOPEZ-AMBROSIO, a.k.a. "Hands," KAREN STEFANY HERNANDEZ-VANEGAS, JUMILCA SANDIVEL HERNANDEZ-PEREZ, ELI ADONIS ESTEBAN-LOPEZ, and WENRY GABRIEL GOMEZ-LOPEZ, sought to accomplish the objectives of the conspiracy included, among other things, the following:

- 1. It was part of the conspiracy that beginning on an unknown date no later than 2020, RONALDO GALINDO LOPEZ-ESCOBAR, a.k.a. "Tio Roni," organized and led a transnational criminal organization with associates in Guatemala, Mexico, and the United States (collectively, the "Lopez Crime Family," hereinafter referred to as, "LCF").
- 2. It was further part of the conspiracy that co-conspirators of **RONALDO GALINDO LOPEZ-ESCOBAR**, a.k.a. "Tio Roni," coordinated with and facilitated the smuggling of Central Americans through Mexico and into the United States in Southern New Mexico and elsewhere.
- 3. It was further part of the conspiracy that ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," and WHISKEY HANS LOPEZ-AMBROSIO, a.k.a. "Hands,"

coordinated with Mexican human smugglers, including JUMILCA SANDIVEL

HERNANDEZ-PEREZ and JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano,"

a.k.a. "Chicken," to cross undocumented aliens from Guatemala through Mexico, and into the

United States through Southern New Mexico.

- 4. It was further part of the conspiracy that upon smuggling undocumented aliens into the United States through Southern New Mexico, ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," and WHISKEY HANS LOPEZ-AMBROSIO, a.k.a. "Hands," would oversee and direct a network of mid-level smugglers including ELI ADONIS ESTEBAN-LOPEZ and WENRY GABRIEL GOMEZ-LOPEZ, who assisted in carrying out the day-to-day operations of the LCF human smuggling business, including the crossing, transportation, and harboring of undocumented aliens.
- 5. It was further part of the conspiracy that KAREN STEFANY HERNANDEZ-VANEGAS, ELI ADONIS ESTEBAN-LOPEZ, and WENRY GABRIEL GOMEZ-LOPEZ received deposits and made payments to co-conspirators through peer-to-peer money transfer applications that were derived from the LCF's human smuggling activity, constituted payments for the costs of the day-to-day operation of the LCF's human smuggling business, and were conducted on behalf of the leadership of the LCF.

Overt Acts

In furtherance of the conspiracy, and to effect the objects thereof, the following overt acts, among others, were committed in the District of New Mexico, and elsewhere:

Overt Act One

In November 2020, **ELVIS BERSAI LOPEZ-AMBROSIO**, **a.k.a.** "Pepe," instructed Co-Conspirator 1 to purchase a house in Deming, New Mexico so that it could be used as an alien smuggling stash house (the "Premises").

Overt Act Two

On or about November 4, 2020, **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," instructed Co-Conspirator 1 to enter into a real estate contract with the sellers of the Premises.

Overt Act Three

On or about November 4, 2020, **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," authorized Co-Conspirator 1 to transmit to the sellers a \$15,000 down payment on the Premises.

Overt Act Four

On or about December 31, 2020, WHISKEY HANS LOPEZ-AMBROSIO, a.k.a. "Hands," received a \$200 Zelle deposit from Co-Conspirator 2, on behalf of ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Five

On or about January 19, 2021, **WENRY GABRIEL GOMEZ-LOPEZ** sent Co-Conspirator 1 a \$600 Zelle deposit, intended to be paid to **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Six

On or about July 9, 2021, **WENRY GABRIEL GOMEZ-LOPEZ** sent Co-Conspirator 1 a \$500 Zelle deposit, intended to be paid to **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "**Pepe**," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Seven

On or about September 3, 2021, **WENRY GABRIEL GOMEZ-LOPEZ** received a \$500 Zelle deposit from Co-Conspirator 2, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Eight

On or about October 28, 2021, **WENRY GABRIEL GOMEZ-LOPEZ** received a \$500 Zelle deposit from Co-Conspirator 3, intended to be paid to **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Nine

On or about January 10, 2022, **ELI ADONIS ESTEBAN-LOPEZ** received a \$1,000 Zelle deposit from Co-Conspirator 3, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, **a.k.a. "Pepe,"** that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Ten

On or about January 11, 2022, JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," utilized a nominee to receive a \$1,500 Zelle deposit from Co-Conspirator 3, on behalf of ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that constituted proceeds owed to JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," for assisting in crossing undocumented aliens from Mexico into the United States for the LCF.

Overt Act Eleven

On or about January 12, 2022, **ELI ADONIS ESTEBAN-LOPEZ** received a \$800 Zelle deposit from Co-Conspirator 3, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Twelve

On or about January 31, 2022, **ELI ADONIS ESTEBAN-LOPEZ** received a \$475 Zelle deposit from Co-Conspirator 2, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Thirteen

On or about February 4, 2022, **ELI ADONIS ESTEBAN-LOPEZ** received a \$500 Zelle deposit from Co-Conspirator 3, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Fourteen

On or about February 22, 2022, **ELI ADONIS ESTEBAN-LOPEZ** received a \$3,500 Zelle deposit from Co-Conspirator 3, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, **a.k.a. "Pepe,"** that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Fifteen

On or about February 22, 2022, **ELI ADONIS ESTEBAN-LOPEZ**, received a \$1,100 Zelle deposit from Co-Conspirator 2, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, **a.k.a. "Pepe,"** that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Sixteen

On or about March 15, 2022, JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," utilized a nominee to receive a \$1,500 Zelle deposit from Co-Conspirator 3, on behalf of ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that

constituted proceeds owed to **JOHN DOE**, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," for assisting in crossing undocumented aliens from Mexico into the United States for the LCF.

Overt Act Seventeen

On or about March 30, 2022, JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," utilized a nominee to receive three Zelle deposits totaling \$3,000 from Co-Conspirator 3, on behalf of ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that constituted proceeds owed to JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," for assisting in crossing undocumented aliens from Mexico into the United States for the LCF.

Overt Act Eighteen

On or about April 2, 2022, **JUMILCA SANDIVEL HERNANDEZ-PEREZ** received a \$1,500 VIAMERICAS money wire from Co-Conspirator 3, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Nineteen

On or about April 18, 2022, **ELI ADONIS ESTEBAN-LOPEZ** received a \$500 Zelle deposit from Co-Conspirator 3, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Twenty

On or about April 19, 2022, **ELI ADONIS ESTEBAN-LOPEZ** received a \$600 Zelle deposit from Co-Conspirator 2, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "**Pepe**," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Twenty-One

On or about April 22, 2022, **ELI ADONIS ESTEBAN-LOPEZ** received a \$530 Zelle deposit from Co-Conspirator 2, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "**Pepe**," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Twenty-Two

On or about April 26, 2022, **ELI ADONIS ESTEBAN-LOPEZ** received a \$600 Zelle deposit from Co-Conspirator 2, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Twenty-Three

On or about April 27, 2022, JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," utilized a nominee to receive a \$500 Zelle deposit from Co-Conspirator 3, on behalf of ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that constituted proceeds owed to JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," for assisting in crossing undocumented aliens from Mexico into the United States for the LCF.

Overt Act Twenty-Four

On or about April 27, 2022, JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," utilized a nominee to receive a \$2,000 Zelle deposit from Co-Conspirator 2, on behalf of ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that constituted proceeds owed to JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," for assisting in crossing undocumented aliens from Mexico into the United States for the LCF.

Overt Act Twenty-Five

On or about April 29, 2022, **ELI ADONIS ESTEBAN-LOPEZ** received a \$500 Zelle deposit from Co-Conspirator 3, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Twenty-Six

On or about June 3, 2022, JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," utilized a nominee to receive two Zelle deposits totaling \$3,500 from Co-Conspirator 3, on behalf of ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that constituted proceeds owed to JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," for assisting in crossing undocumented aliens from Mexico into the United States for the LCF.

Overt Act Twenty-Seven

On or about June 5, 2022, JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," utilized a nominee to receive two Zelle deposits totaling \$2,000 from Co-Conspirator 3, on behalf of ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that constituted proceeds owed to JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," for assisting in crossing undocumented aliens from Mexico into the United States for the LCF.

Overt Act Twenty-Eight

On or about July 22, 2022, Co-Conspirator 3 received a \$130 Zelle deposit from KAREN STEFANY HERNANDEZ-VANEGAS, intended to be paid to ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Twenty-Nine

On or about August 8, 2022, JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," utilized a nominee to receive a \$3,500 Zelle deposit from Co-Conspirator 2, on behalf of ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that constituted proceeds owed to JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," for assisting in crossing undocumented aliens from Mexico into the United States for the LCF.

Overt Act Thirty

On or about August 9, 2022, WHISKEY HANS LOPEZ-AMBROSIO, a.k.a. "Hands," received a \$730 Zelle deposit from Co-Conspirator 3, on behalf of ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Thirty-One

On or about August 14, 2022, JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," utilized a nominee to receive two Zelle deposits totaling \$3,000 from Co-Conspirator 3, on behalf of ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that constituted proceeds owed to JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," for assisting in crossing undocumented aliens from Mexico into the United States for the LCF.

Overt Act Thirty-Two

On or about August 22, 2022, **ELI ADONIS ESTEBAN-LOPEZ** received a \$1,500 Zelle deposit from Co-Conspirator 2, on behalf of **ELVIS BERSAI LOPEZ-AMBROSIO**, **a.k.a. "Pepe,"** that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Thirty-Three

On or about September 9, 2022, KAREN STEFANY HERNANDEZ-VANEGAS received a \$700 Zelle deposit from Co-Conspirator 2, on behalf of ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Thirty-Four

On or about September 9, 2022, JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," utilized a nominee to receive a \$700 Zelle deposit from Co-Conspirator 2, on behalf of ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," that constituted proceeds owed to JOHN DOE, a.k.a. "Chikis," a.k.a. "Chiquis," a.k.a. "Enano," a.k.a. "Chicken," for assisting in crossing undocumented aliens from Mexico into the United States for the LCF.

Overt Act Thirty-Five

On or about September 12, 2022, **ELI ADONIS ESTEBAN-LOPEZ** sent Co-Conspirator 3 a \$500 Zelle deposit, intended to be paid to **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Thirty-Six

On or about September 12, 2022, **WENRY GABRIEL GOMEZ-LOPEZ** sent Co-Conspirator 3 a \$2,500 Zelle deposit, intended to be paid to **ELVIS BERSAI LOPEZ-AMBROSIO**, a.k.a. "Pepe," that constituted operational expenses for the LCF's alien smuggling business.

Overt Act Thirty-Seven

On or about April 6, 2023, **WHISKEY HANS LOPEZ-AMBROSIO**, **a.k.a.** "Hands," instructed Co-Conspirator 4 to pick up a group of undocumented aliens in New Mexico and transport the group in exchange for money.

Overt Act Thirty-Eight

On or about April 6, 2023, at the instruction of **WHISKEY HANS LOPEZ-AMBROSIO**, a.k.a. "Hands," Co-Conspirator 4 picked up a group of undocumented aliens in New Mexico and transported them until Co-Conspirator 4 was apprehended by law enforcement agents.

Overt Act Thirty-Nine

On or about April 7, 2023, **WHISKEY HANS LOPEZ-AMBROSIO**, **a.k.a.** "Hands," instructed Co-Conspirator 5 to pick up a group of undocumented aliens in New Mexico and transport the group in exchange for money.

Overt Act Forty

On or about April 7, 2023, at the instruction of **WHISKEY HANS LOPEZ-AMBROSIO**, a.k.a. "Hands," Co-Conspirator 5 picked up a group of undocumented aliens and transported the group through New Mexico until Co-Conspirator 5 was apprehended by law enforcement agents.

In violation of 8 U.S.C. $\S 1324(a)(1)(A)(v)(I)$.

Count 2

From on or about March 13, 2020, and continuing to on or about August 22, 2022, in Doña Ana County, in the District of New Mexico, and elsewhere, the defendants, RONALDO GALINDO LOPEZ-ESCOBAR, a.k.a. "Tio Roni," and ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," knowingly combined, conspired, confederated, agreed, and acted

interdependently with each other and with other persons whose names are known and unknown to the Grand Jury to commit certain offenses defined in 18 U.S.C. §§ 1956 and 1957, as follows:

- a. Conducted and attempted to conduct financial transactions in interstate commerce, which transactions involved the proceeds of specified unlawful activity, that is, transporting and harboring illegal aliens as defined in 8 U.S.C. §§ 1324(a)(1)(A)(ii) and (iii), knowing that the transactions were designed in whole and in part to conceal and disguise the nature, location, source, ownership, and control of the proceeds of specified unlawful activity, and that while conducting and attempting to conduct such financial transactions, knew that the property involved in the financial transactions represented the proceeds of some form of unlawful activity, in violation of 18 U.S.C. § 1956(a)(1)(B)(i); and
- b. Knowingly engaged, attempted to engage, and caused and aided or abetted others in engaging in monetary transactions by, through, or to a financial institution, affecting interstate commerce, in criminally-derived property of a value greater than \$10,000, such property having been derived from a specified unlawful activity, that is, transporting and harboring illegal aliens as defined in 8 U.S.C. §§ 1324(a)(1)(A)(ii) and (iii), in violation of 18 U.S.C. § 1957.

Manner and Means

The manner and means by which the defendants, RONALDO GALINDO LOPEZ-ESCOBAR, a.k.a. "Tio Roni," and ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," sought to accomplish the objectives of the conspiracy included, among other things the following:

- 1. It was part of the conspiracy that that ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," would instruct co-conspirators to open United States bank accounts in order to receive smuggling fees from smuggled aliens on ELVIS BERSAI LOPEZ-AMBROSIO's, a.k.a. "Pepe," behalf in a manner that would be untraceable to ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe."
- 2. It was further part of the conspiracy that upon receiving the smuggling fees,

 ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a. "Pepe," would instruct co-conspirators to

 withdraw the funds and either: give the funds to ELVIS BERSAI LOPEZ-AMBROSIO, a.k.a.

 "Pepe," convert the funds into assets including real estate, or send funds to RONALDO

 GALINDO LOPEZ-ESCOBAR, a.k.a. "Tio Roni," or his nominees in Guatemala to minimize

 the traceability of the funds to RONALDO GALINDO LOPEZ-ESCOBAR, a.k.a. "Tio

 Roni."

Overt Acts

In furtherance of the conspiracy, and to effect the objects thereof, the following overt acts, among others, were committed in the District of New Mexico, and elsewhere:

it is the intent of the United States, pursuant to 21 U.S.C. § 853(p), as incorporated by 18 U.S.C. § 982(b)(1), to seek forfeiture of any other property of the defendants up to the value of the forfeitable property described above.
