COUNT ONE

The Grand Jury charges:

1. On or about March 4, 1999, in the Southern District of New York, JOSE ALVAREZ, a/k/a "Ignacio Alvarez," the defendant, and others known and unknown, willfully and knowingly, during and in relation to a crime of violence for which they may be prosecuted in a court of the United States, namely, the attempted robbery of Jose Miguel Mendez of narcotics and narcotics proceeds, and during and in relation to a drug trafficking crime for which they may be prosecuted in a court of the United States, namely, a conspiracy to distribute and possess with intent to distribute more than five kilograms of cocaine and more than one kilogram of heroin, in violation of Title 21, United States Code, Section 846, did use and carry a firearm, and, in furtherance of such crime, did possess a firearm, and did aid and abet the use, carrying, and possession of a firearm, and in the course of that crime did cause the death of

a person through the use of a firearm, which killing is murder as defined in Title 18, United States Code, Section 1111(a), to wit, ALVAREZ and other individuals not named as defendants herein caused the death of Jose Miguel Mendez, by discharging and aiding and abetting the discharge of a firearm at Mendez.

COUNT TWO

The Grand Jury further charges:

2. On or about March 4, 1999, in the Southern District of New York, while engaged in an offense punishable under Section 841(b)(1)(A) of Title 21, United States Code, namely, a narcotics conspiracy to distribute and possess with the intent to distribute more than five kilograms of cocaine and more than one kilogram of heroin, JOSE ALVAREZ, a/k/a "Ignacio Alvarez," the defendant, and others known and unknown, intentionally and knowingly killed and counseled, commanded, inducted, procured, and caused the intentional killing of Jose Miguel Mendez and such killing resulted.

(Title 21, United States Code, Section 848(e)(1)(A), Title 18, United States Code, Section 2.)
