The Grand Jury Charges:

COUNT 1

18 U.S.C. § 922(d)(1)
(Unlawful Disposition of a Firearm)

On or about January 7, 2026, in the District of Utah,

RYAN DANIEL TOUTAI (aka "LOST ONE"),

defendant herein, disposed of a firearm, to wit: a Ruger LC9 9mm semi-automatic pistol, to FINEEVA POMANA MAKKA, knowing and having reasonable cause to believe that FINEEVA POMANA MAKKA had been convicted of a crime punishable by imprisonment for a term exceeding one year; all in violation of 18 U.S.C. § 922(d)(1) and punishable pursuant to 18 U.S.C. § 924(a)(8).

COUNT 2

18 U.S.C. § 922(g)(1)
(Felon in Possession of a Firearm)

On or about January 7, 2026, in the District of Utah,

FINEEVA POMANA MAKKA (aka “FINLOC”),

defendant herein, knowing he had previously been convicted of a crime punishable by imprisonment for a term exceeding one year, knowingly possessed a firearm, to wit: a Ruger LC9 9mm semi-automatic pistol, and the firearm was in and affecting commerce; all in violation of 18 U.S.C. § 922(g)(1) and punishable pursuant to 18 U.S.C. § 924(a)(8).

NOTICE OF INTENT TO SEEK FORFEITURE

Pursuant to 18 U.S.C. § 924(d)(1) and 28 U.S.C. § 2461(c), upon conviction for any offense violating 18 U.S.C. § 922, the defendants shall forfeit to the United States of America any firearm involved in or used in the commission of the offense, including but not limited to:
