## COUNT 26

On or about June 28, 2013, in the Western District of Kentucky, Marshall County, Kentucky, and elsewhere, **JEFFREY DESMOND CARTER**, defendant herein, knowingly recruited, enticed, harbored, transported, provided or obtained a person (Victim 12), knowing, and in reckless disregard of the fact, that Victim 12 had not attained the age of eighteen years and would be caused to engage in a commercial sex act, as that term is defined in Title 18, United States Code, Section 1591(e)(3), in and affecting interstate and foreign commerce.

In violation of Title 18, United States Code, Sections 1591(a) and 1591(b)(2).

The Grand Jury further charges:

## COUNT 27

On or about September 15, 2013, in the Western District of Kentucky, Marshall County, Kentucky, and elsewhere, **JEFFREY DESMOND CARTER**, defendant herein, knowingly used, persuaded, induced, enticed, and coerced a minor, (Victim 12), to engage in sexually explicit conduct for the purpose of producing any visual depiction of such conduct, which were produced and transmitted using materials that had been mailed, shipped, and transported in and affecting interstate and foreign commerce by any means, including by computer.

In violation of Title 18, United States Code, Sections 2251(a) and 2251(e).

#### NOTICE OF FORFEITURE

As a result of committing offenses in violation of Title 18, United States Code, Sections 2251(a), 2251(e), 2252A(a)(2)(B), and 2252A(b)(1), as alleged in Counts 1-25 and 27 of this Indictment, felonies punishable by imprisonment for more than one year, the defendant,

JEFFREY DESMOND CARTER, shall forfeit to the United States, pursuant to Title 18, United

States Code, Section 2253:

1. Any property, real and personal, used and intended to be used to commit and to promote

the commission of such offense; and

2. All visual depictions which were produced, transported, mailed, shipped, or received

in violation of the law.

Further, as a result of committing an offense in violation of Title 18, United States Code, Sections

1591(a) and 1591(b)(2), as alleged in Count 26 of this Indictment, a felony punishable by

imprisonment for more than one year, the defendant, JEFFREY DESMOND CARTER, shall

forfeit to the United States, pursuant to Title 18, United States Code, Section 1594(e)(1)(A) and

(B):

1. Any property, real or personal, used or intended to be used to commit or to facilitate

the commission of any such offense; and

2. Any property, real or personal, which constitutes or is derived from proceeds traceable

to any such violation.

#### NOTICE

#### ANY PERSON CONVICTED OF AN OFFENSE AGAINST THE UNITED STATES SHALL BE SUBJECT TO SPECIAL ASSESSMENTS, FINES, RESTITUTION & COSTS.

#### SPECIAL ASSESSMENTS

18 U.S.C. § 3013 requires that a special assessment shall be imposed for each count of a conviction of offenses committed after November 11, 1984, as follows:

Misdemeanor:

\$ 25 per count/individual

Felony:

\$100 per count/individual

#### **FINES**

In addition to any of the above assessments, you may also be sentenced to pay a fine.
