**PERMANENT INJUNCTION**

Before the Court is the parties' stipulation for permanent injunction. For good cause shown therein and upon the stipulation and agreement of the parties:

**IT IS HEREBY ORDERED** pursuant to 26 U.S.C. §§ 7402(a), 7407, and 7408 that defendant Joyce Bougere-Keyes, individually and doing business as Joyce Tax & Financial Service, LLC or any other entity, and any other person or entity working in concert or participation with her directly or indirectly, is **PERMANENTLY ENJOINED** from directly or indirectly:

1. preparing, assisting in the preparation of, or directing the preparation of federal tax returns, amended returns, or other tax-related documents and forms, including any electronically-submitted tax returns or tax-related documents, for any entity or person other than herself;
  2. engaging in conduct subject to penalty under 26 U.S.C. §§ 6694, 6695(g), and 6701;

3. engaging in any conduct that interferes with the proper administration and enforcement of the internal revenue laws;


**IT IS FURTHER ORDERED** that Bougere-Keyes:

1. At her own expense notify each person for whom she prepared federal income tax returns or any other federal tax forms after January 1, 2010 that she has been permanently barred from preparing tax returns and provide each person;
2. Consents, without further proceedings, to immediate revocation of any Preparer Tax Identification Number (PTIN) that is held by, or assigned to, or used by her, pursuant to 26 U.S.C. § 6109, and any Electronic Filing Identification Number (EFIN) held by, assigned to, or used by her.
3. Provide to the United States a sworn statement evidencing her compliance with the foregoing directives within forty-five (45) days of entry of this order; and
4. Keep records of her compliance with the foregoing directives, which may be produced to the Court, if requested, or the United States in post-judgment discovery, if requested;

**IT IS FURTHER ORDERED** that the United States will be allowed full post-judgment discovery to monitor compliance with the permanent injunction; and

**IT IS FURTHER ORDERED** that the Court will retain jurisdiction over this action for purpose of implementing and enforcing the permanent injunction and any additional orders necessary and appropriate to the public interest.


