CRIMINAL COMPLAINT

I, the undersigned complainant, being duly sworn, state the following is true and correct to the best of my knowledge and belief:

COUNT ONE

Possession With Intent to Distribute 500 Grams or More of Methamphetamine

On or about March 26, 2025, in the Western District of Missouri, the defendant, JOSE C. VALENCIA-SORIANO, did knowingly and intentionally possess with the intent to distribute 500 grams or more of a mixture or substance containing a detectable amount of methamphetamine, a Schedule II controlled substance, in violation of Title 21, United States Code, Sections 841(a)(1) and (b)(1)(A).

COUNT TWO

Possession of a Firearm During a Drug Trafficking Crime

On or about March 26, 2025, in the Western District of Missouri, the defendant, JOSE C. VALENCIA-SORIANO, in furtherance of and during and in relation to a drug trafficking crime for which he may be prosecuted, did knowingly and intentionally carry and possess a firearm and ammunition, to wit: an AR style firearm, 5.56 caliber, bearing serial number DB2903544, all contrary to the provisions of Title 18, United States Code, Section 924(c)(1)(A)(i).

COUNT THREE

Alien in Possession of a Firearm

On or about March 26, 2025, in the Western District of Missouri, the defendant, JOSE C. VALENCIA-SORIANO, a citizen of the Country of Mexico, knowing he was present in the United States illegally and unlawfully, did knowingly possess, in and affecting interstate commerce, a firearm, to wit: an AR style firearm, 5.56 caliber, bearing serial number DB2903544; Smith and Wesson 9mm handgun, bearing serial number HUR3679; and a Colt M4A1 rifle, 5.56 caliber, bearing serial number CR858707, which had been transported in interstate commerce, all in violation of Title 18, United States Code, Sections 922(g)(5)(A) and 924(a)(8).
