  - Change your living arrangements, such as relocating to a less expensive home; or
  - Experience difficulty obtaining credit, or harm to your credit?
- *Emotional Impact:* Has this crime affected you in non-monetary ways, such as causing you increased stress, anxiety, or depression? Have you more distrustful? Have you needed any mental health services as a result? How have you been affected in your ability to enjoy activities that you previously enjoyed?
- *Social Impact:* How has this crime impacted your relationships with family members, friends, coworkers, and others? Did defendants' crime result in your feeling isolated or alienated? Did defendants' crime cause you to suffer any reputational harm?

In addition to discussing how this crime has impacted you, this is your opportunity to let the Court know what you would like to see happen to the defendants.

You also have the option of attending the sentencing hearing and providing your statement in person. You may also contact the U.S Probation Officer who is compiling the pre-sentence investigation report for the Court to let them know how this crime has impacted you.
