COUNT TWO: (18 U.S.C. § 2251(a) - Production of Child Pornography)

On or about April 13, 2009, in the Northern District of California, the defendant,

## DYLAN JOSH ZARA,

did knowingly employ, use, persuade, induce, entice, and coerce a minor known here as Child Victim 2 to engage in, and to assist him in engaging in, sexually explicit conduct for the purpose of producing a visual depiction of such conduct, and such visual depiction was produced using materials that have been mailed, shipped, and transported in and affecting interstate and foreign commerce by any means, including by computer, in violation of Title 18, United States Code, Section 2251(a).

COUNT THREE: (18 U.S.C. § 2251(d) – Advertisement of Child Pornography)

On or about April 1, 2009, in the Northern District of California, the defendant,

## DYLAN JOSH ZARA.

did knowingly make, print, and publish, and cause to be made, printed, and published, notices and advertisements seeking to receive, exchange, produce, and distribute, visual depictions involving the use of minors engaged in sexually explicit conduct, the production of such visual depictions having involved the use of a minor engaged in sexually explicit conduct and being of such conduct, knowing and having reason to know that such notices and advertisements will be transported using any means and facility of interstate or foreign commerce, and in and affecting interstate and foreign commerce by any means, including by computer, in violation of Title 18, United States Code, Section 2251(d).

COUNT FOUR: (18 U.S.C. § 2252(a)(2) – Distribution of Child Pornography)

On or about May 4, 2009, in the Northern District of California, the defendant,

## DYLAN JOSH ZARA,

did knowingly distribute visual depictions, to wit the image files DSC04651-500 and DSC3856, that had been mailed and shipped and transported in and affecting interstate and foreign commerce, and which contain materials which had been so mailed and shipped and transported by any means, including by computer, the production of which involved the use of a minor engaging in sexually explicit conduct and which visual depiction was of such conduct, in violation of Title 18, United States Code, Section 2252(a)(2).

COUNT FIVE: (18 U.S.C. § 2252(a)(2) – Distribution of Child Pornography)

On or about December 17, 2009, in the Northern District of California, the defendant,

#### DYLAN JOSH ZARA,

did knowingly distribute visual depictions, to wit the image file DSC06289, that had been mailed and shipped and transported in and affecting interstate and foreign commerce, and which contain materials which had been so mailed and shipped and transported by any means, including by computer, the production of which involved the use of a minor engaging in sexually explicit conduct and which visual depiction was of such conduct, in violation of Title 18, United States Code, Section 2252(a)(2).

COUNT SIX: (18 U.S.C. § 2252(a)(4)(B) - Possession of Child Pornography)

On or about July 22, 2011, in the Northern District of California, the defendant,

#### DYLAN JOSH ZARA,

did knowingly possess at least one matter which contained a visual depiction that had been mailed, shipped and transported in and affecting interstate and foreign commerce, and which was produced using materials which had been mailed, shipped and transported in interstate and foreign commerce, by any means including by computer, the production of such visual depiction having involved the use of a minor engaging in sexually explicit conduct, and such depiction was

of such conduct; in violation of Title 18, United States Code, Section 2252(a)(4)(B).
