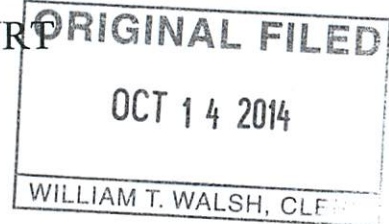

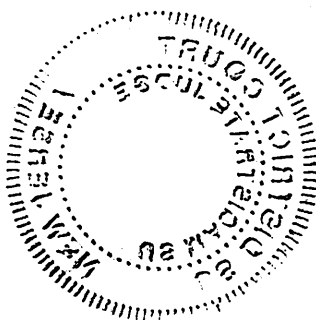

COUNT ONE

From in or about August 2014 through in or about October 2014, in Camden County, in the District of New Jersey and elsewhere, defendants

WENDELL FLEETWOOD, a/k/a "Dell,"
WENDELL BETHEA, a/k/a "Rell," a/k/a "Ruger,"
BRANDON JONES,
JULIO ALVARADO
and
ERICA FLEETWOOD,

did knowingly and intentionally conspire and agree with each other and with others to distribute and possess with intent to distribute controlled substances, specifically: (1) 100 grams or more of a mixture and substance containing a detectable amount of heroin, a Schedule I controlled substance, contrary to Title 21, United States Code, Sections 841(a)(1) and (b)(1)(B), and (2) 50 grams or more of methamphetamine, also known as "Ice," a Schedule II controlled substance, contrary to Title 21, United States Code, Sections 841(a)(1) and (b)(1)(A).

In violation of Title 21, United States Code, Section 846.

COUNT TWO

On or about September 8, 2014, in Camden County, in the District of New Jersey and elsewhere, defendants

did knowingly and intentionally distribute and possess with the intent to distribute, and aid and abet the distribution of, 100 grams or more of a mixture and substance containing a detectable amount of heroin, a Schedule I controlled substance.

In violation of Title 21, United States Code, Sections 841(a) and 841(b)(1)(B), and Title 18, United States Code, Section 2.

COUNT THREE

On or about September 17, 2014, in Camden County, in the District of New Jersey and elsewhere, defendants

WENDELL BETHEA, a/k/a "Rell," a/k/a "Ruger,"

did knowingly and intentionally distribute and possess with the intent to distribute, and aid and abet the distribution of, 100 grams or more of a mixture and substance containing a detectable amount of heroin, a Schedule I controlled substance.
