1. On or about April 23, 2013, in Passaic County, in the District of New Jersey, and elsewhere, the defendant,

KEVIN REASE,

did knowingly possess material that contained at least three images of child pornography, as defined in Title 18, United States Code, Section 2256(8), including images of child pornography involving a prepubescent minor and a minor who had not attained 12 years of age, which images had been mailed, shipped, and transported using any means and facility of interstate and foreign commerce and in and affecting interstate and foreign commerce by any means, including by computer, and which were produced using materials that were shipped and transported in and affecting interstate and foreign commerce, by any means, including by computer, after having been convicted in the District of New Jersey of Transportation of Child Pornography, in violation of Title 18, United States Code, Section 2252A(a)(1) and in Essex County Superior Court of Sexual Assault by Sexual Contact, in violation of N.J.S.A. 2C:14-2b, Luring, in violation of N.J.S.A. 2C:13-6, and Endangering the Welfare of a Child, in violation of N.J.S.A. 2C:24-4.
