## THIRD NATIONAL TAKE BACK INITIATIVE TO BE HELD OCTOBER 29<sup>TH</sup>

BUFFALO, N.Y.--U.S. Attorney William J. Hochul Jr. and Drug Enforcement Administration Resident Agent in Charge Dale Kasprzyk today announced the Western New York locations for the third National Take Back Initiative. Tomorrow, October 29<sup>th</sup> from 10:00A.M. to 2:00 P.M., the DEA will be collecting potentially dangerous prescription drugs that are unused or unwanted.

During the first two National Take Back events in September 2010 and April 2011, Americans turned in 309 tons of prescription drugs. Seven tons were collected here in Western New York.

The event is free and anonymous with no questions asked. The public can drop off expired, unused or unwanted prescription drugs which could be dangerous if left in the family's medicine cabinet.

"Prescription drug abuse is the nation's fastest growing drug problem and we here in Western New York are not immune to it," said U.S. Attorney Hochul. "Leaders in law enforcement, education, medicine, government and the community at large are working jointly to address this epidemic. These drug take back events are an important component of those efforts to keep prescription drugs from getting into the wrong hands, especially those of our young people."

"We all have another unique opportunity to contribute to the fight against prescription drug abuse by participating in the third National Prescription Drug Take-Back Day event," said DEA Administrator Michele M. Leonhart. "Americans overwhelmingly responded to the first two national Take-Back Day events, and we hope the October 29th event is no

different. With everyone's support, we can reduce the risk of prescription drug diversion and abuse, while increasing the awareness of this important public health issue."
