### U.S. ATTORNEY'S OFFICE CO-HOSTS 2<sup>ND</sup> ANNUAL NEW AMERICAN CIVIL RIGHTS TOWN HALL.

The U.S. Attorney's Office Southern District of Ohio coordinated with the Ohio Latino Affairs Commission, the Ohio Asian American and Pacific Islander Advisory Council, and the Columbus Community Relations Commission to host the second annual New American Civil Rights Town Hall April 15 at the Riffe Center in Columbus.



At the first summit in April 2013, community leaders gathered in Columbus to talk about employment, housing, and language rights, hate crimes, and police relations.

In the spirit of continued cultural competency and collaboration, the second annual summit included in-depth discussion of hate crimes and building relations between the community and law enforcement.

Betsy Biffl, a criminal prosecutor with the Civil Rights Division of the U.S. Department of Justice, served as the keynote speaker. She educated participants on the work of the Division and provided examples of hate crimes cases.

Representatives from the U.S. Attorney's Office, FBI, Ohio Council on American-Islamic Relations, The Ohio State University, U.S. Department of Homeland Security Civil Rights Civil Liberties Section, Columbus Community Relations Commission, Porter Wright, and the Westerville Division of Police served as expert panelists.



The event included a resource fair with officials on hand from U.S. Citizen and Immigration Services, the Equal Employment Opportunity Commission, Columbus Police Department, Ohio Domestic Violence Network, and Ohio Department of Job and Family Services Civil Rights Bureau.

The event closed with a panel of students sharing their experiences as early childhood arrivals to America.

The goal of the event was to bring together those who have immigrated to Ohio from places all over the world to understand their rights, learn best practices, and work together to create better communities for all.

#### URBAN INSTITUTE STUDIES UNDERGROUND SEX ECONOMY

The Urban Institute's Justice Policy Center released a study last month examining the size and structure of underground commercial sex economies in eight major cities: San Diego, Seattle, Dallas, Denver, Washington D.C., Miami, Atlanta, and Kansas City.

Through the center's three-year study, which was funded by the Department of Justice, they highlight entrance into the commercial sex business, media portrayal, the role of women, family, and friends, and the influence of the Internet.

The study examines the perception by those involved that the underground sex economy is low-risk.

The researchers also consider the increasing amount of child pornography being produced in the United States, and it's increasingly graphic and violent nature.

Finally, the report names suggestions for policy and practice to help combat trafficking.

### FUSION CENTER HOSTS COLUMBUS COMMUNITY ENGAGEMENT COUNCIL

The Columbus Community Engagement Council (CCEC) gathered for its quarterly meeting January 29 at the Ohio Department of Public Safety.

Ohio Homeland Security's Strategic Analysis & Information Center (also known as the Fusion Center) graciously hosted the group. Heather Frient, Jeff Dickey, Tom Gerber, Mustafa Mirza, and Patrick Seaman provided an overview of the Fusion Center and considerations taken regarding privacy rights, civil rights, and civil liberties.

As Heather described using a wheel analogy, the Fusion Center serves as a hub of information, while federal, state, and local government agencies, law enforcement, and private sector partners serve as the spokes. The Fusion Center receives, analyzes, gathers, and shares threat-related information.

The group also discussed the U.S. Department of Justice's Human Rights and Special Prosecutions (HRSP) section. HRSP works with other federal government agencies to identify and prosecute human rights violators. Examples of the types of crimes prosecuted include genocide, torture, war crimes, and the use or recruitment of child soldiers. HRSP asks that if you know of anyone who is now in the U.S. and may have been involved in human rights violations in another country that you call 1-800-813-5863 and leave a message (in any language) or email <a href="mailto:hrsptips@usdoj.gov">hrsptips@usdoj.gov</a>. Tips can be left anonymously.

Those in attendance included Kim Welter (Equality Ohio), J.S. Jindal and Abdi Soofe (Community Relations Commission), Un Jung Lim (ODVN), Mahdi Warsama (Masjid-As-Salaamah), and Ken Parker and Jennifer Thornton (U.S. Attorney's Office).

The intent of the CCEC is to build relationships with and learn from community leaders who represent the city's diversity in terms of ethnicity, religion, and sexual orientation.

#### SERVING VICTIMS OF HUMAN TRAFFICKING IN OHIO

The Ohio Department of Public Safety has compiled a <u>Toolkit for Serving Victims of Human Trafficking in Ohio</u>, which will serve as a framework for The Ohio Human Trafficking Task Force, the Ohio Network of Anti-Human Trafficking Coalitions, and the Ohio Human Trafficking Commission.



The website and toolkit includes awareness campaign materials, information on state and federal laws, funding resources, service standards, media guides, and response models. It also provides an interactive map of anti-trafficking organizations serving victims and raising awareness throughout the state.

#### President Obama Launches 'My Brother's Keeper' Initiative

In late February, President Obama announced his My Brother's Keeper Initiative. This is a major public-private effort designed to give every boy and young man of color who is willing to work hard and play by the rules the chance to reach his full potential. It's aimed at finding ways that community leaders, businesses, philanthropies, and – of course – government can work together to create opportunities for these young men and send the message that our country wants them to be a full part of this society.

There are two parts to this effort. There's a federal task force set up to evaluate the impact of existing federal programs and lift up what works. The second component is a group of leading foundations that have come together to support the President's call to action. They're joining together to identify the most effective ways of expanding access to opportunity in partnership with non-profit and private sector organizations.

The President's announcement at the White House marked the launch of a 90-day process to examine existing federal policies and programs, evaluate the results, and identify what works and key opportunities for action.

The focus of My Brother's Keeper is on several important areas – youth violence, contact with the juvenile and criminal justice systems, education, and economic mobility. The role of the Department of Justice is preventing and reducing violence among young men of color, addressing their overrepresentation in the justice system, and ensuring that those

Stewart educated the crowd on Internet crimes and child exploitation and how to protect their children and themselves online.



His tips to parents included:

- Communicate with your kids! Start early and talk often about Internet safety.
- Establish ground rules and stick to those rules set parameters of time and acceptable locations for your child to use the Internet.
  - Learn how to use parental controls.
  - Don't be afraid of the Internet and try to stay current.
- Remind your children that using the Internet is like other privileges that they enjoy. All privileges have rules, safety measure, and consequences when the rules are not followed.
