THE GRAND JURY CHARGES:

Count 1

On or about June 19, 2014, in Hazleton, Pennsylvania, within the Middle District of Pennsylvania, the defendant,

LEE SOKALSKY,

by force, violence and intimidation, did intentionally take from the person and presence of another, money, approximately \$10,095.00 in United States Currency, belonging to and in the care, custody, control, management and possession of the First National Community Bank, 340 West Broad Street, Hazleton, Pennsylvania, a bank whose deposits were then insured by the Federal Deposit Insurance Corporation.

In violation of Title 18, United States Code, Section 2113(a).

Count 2

On or about July 25, 2014, in Dickson City, Pennsylvania, within the Middle District of Pennsylvania, the defendant,

LEE SOKALSKY,

by force, violence and intimidation, did intentionally take from the person and presence of another, money, approximately \$10,479.25 in United States Currency, belonging to and in the care, custody, control, management and possession of the NBT Bank, 736 Main Street, Dickson City, Pennsylvania, a bank whose deposits were then insured by the Federal Deposit Insurance Corporation.

In violation of Title 18, United States Code, Section 2113(a).

Count 3

On or about August 26, 2014, in Hazleton, Pennsylvania, within the Middle District of Pennsylvania, the defendant,

LEE SOKALSKY,

did attempt to intentionally take from the person and presence of another, money, belonging to and in the care, custody, control, management and possession of the First National Community Bank, 340 West Broad Street, Hazleton, Pennsylvania, a bank whose deposits were then insured by the Federal Deposit Insurance Corporation.

In violation of Title 18, United States Code, Section 2113(a).

Count 4

On or about August 26, 2014, in Tamaqua, Pennsylvania, within the Middle District of Pennsylvania, the defendant,

LEE SOKALSKY

by force, violence and intimidation, did intentionally take from the person and presence of another, money, approximately \$25,159.00 in United States Currency, belonging to and in the care, custody, control, management and possession of the Mauch Chunk Trust Bank, 226 Claremont Avenue, Tamaqua, Pennsylvania, a bank whose deposits were then insured by the Federal Deposit Insurance Corporation.

In violation of Title 18, United States Code, Sections 2113(a).

Count 5

On or about September 20, 2014, in Drums, Pennsylvania, within the Middle District of Pennsylvania, the defendant,

LEE SOKALSKY,

by force, violence and intimidation, did intentionally take from the person and presence of another, money, approximately \$16,115.80 in United States Currency, belonging to and in the care, custody, control, management and possession of the National Penn Bank, 24 South Hunter Highway, Drums, Pennsylvania, a bank whose deposits were then insured by the Federal Deposit Insurance Corporation.

In violation of Title 18, United States Code, Sections 2113(a).

Count 6

On or about October 10, 2014, in Hazle Township, Pennsylvania, within the Middle District of Pennsylvania, the defendant,

LEE SOKALSKY,

by force, violence and intimidation, did intentionally take from the person and presence of another, money, approximately \$157,139.56 in United States Currency, belonging to and in the care, custody, control, management and possession of the M&T Bank, Laurel Mall, Hazle Township, Pennsylvania, a bank whose deposits were then insured by the Federal Deposit Insurance Corporation, and in committing such offense, the defendant did assault another person by the use of a dangerous weapon, that is, a handgun.

In violation of Title 18, United States Code, Sections 2113(d).
