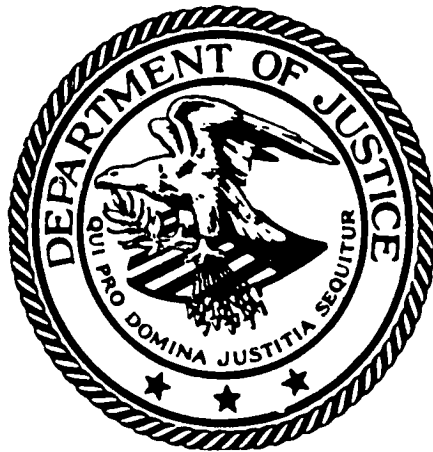

WORK HANDLED BY UNITED STATES ATTORNEYS' OFFICES
DURING FISCAL YEAR 1967

CRIMINAL CASES

FILED - Criminal filings amounting to 33,985 showed an increase of 1,352 or 4.1 per cent from the number filed in the previous fiscal year. About 69.6 per cent of the total was in 13 offenses having 500 or more cases; seven showed increases while 6 showed decreases. The largest increases occurred in Selective Service (642 to 1306), Bank Robbery (849 to 1016) and Narcotics (2293 to 2636). National Motor Vehicle Act dropped from 4900 to 4742 and Income Tax from 863 to 782; Counterfeiting and Forgery dropped from 2109 to 1936. Increases took place in 50 districts ranging from 158 in Florida Southern to 1 in Montana. Decreases took place in 40 districts ranging from 109 in Illinois Northern to 3 in Guam.

TERMINATED - Cases terminated decreased 653 or 2.0 per cent under the previous year's total. Of the total of 31,233 closed, 20,782 involving 24,162 defendants were by pleas of guilty, 2,747 (involving 3,482 defendants) were found guilty after trial and 825 (involving 1,202 defendants) not guilty.

PENDING - With 14,895 cases, the pending caseload showed an increase of 22.7 per cent over 12,143* cases pending at the close of fiscal year 1966. 12,848 were in triable status, while 2,047 were in a fugitive or other status beyond the control of the United States Attorneys.

GRAND JURY PROCEEDINGS

Grand Jury Proceedings comprised of 18,663 indictments and 534 No True Bills amounted to 19,197, an increase of 8.4 per cent over the previous fiscal year for the highest total since fiscal year 1953.

CRIMINAL COMPLAINTS

RECEIVED - Complaints received reached 132,101 for the highest total in the history of the Department. This is 6.95 per cent more than the 123,520 received in fiscal year 1966.

Southern California with 7,971 had the most complaints and Southern New York with 5,571 and Eastern New York with 4,623 were the next highest. 87,533 of the complaints were in eleven offenses as shown below:

CLOSED - 97,031 complaints were closed during 1967 without reaching court dockets. Of this number, 84,239 or 86.8 per cent of the total were closed by declination of prosecution.

PENDING - Criminal complaints pending as of June 30, 1967 rose to 18,360, an increase of 2,687 or 17.1 per cent over the 15,673 pending as of June 30, 1966.

CIVIL CASES

FILED - Civil cases filed amounted to 28,676, a decrease of 1,394 or 4.6 per cent under the previous year's total. 29 districts had increases, and 61 districts showed decreases from the previous year. 13,957 or 48.7 per cent of the total was in seventeen districts having filings ranging from 504 to 1,412. Tax Lien cases with 5,168, Tort cases with 2,159 and General Claims cases with 6,390 had 18.0, 7.5, and 22.3 per cent respectively of the cases filed.

TERMINATED - With 47 districts showing decreases, civil cases terminated dropped to 28,987. This total is under fiscal year 1966's total by 237 or .8 per cent. Decreases ranged from 271 in Arizona to 2 in Indiana Northern while increases ranged from 2 in Maine to 304 in Florida Southern.

1,086 of these cases were suits in which the government as defendant was sued for \$100,537,880. 600 of them involving \$44,918,130 were closed by compromises amounting to \$8,198,202 and 165 involving \$18,297,283 resulted in judgments against the government amounting to \$7,747,498. The remaining 321 cases involving \$37,322,467 were won by the government, thus bringing the savings to \$84,592,180, a decrease of \$47,998,460 or 36.2 per cent from the \$132,590,640 saved in Fiscal Year 1966.

PENDING - Civil cases pending as of the close of the fiscal year decreased by 311 or 1.3 per cent to 24,458. 10,694 or 43.7 per cent of the caseload was in twelve districts with caseloads ranging from 1,421 in Florida Middle to 610 in Southern Ohio. Tax Lien cases with 4,090 increased to 16.7 per cent of the total as compared to 3,680 or 14.8 per cent of the total pending as of June 30, 1966. Land cases with 1,841 or 7.5 per cent decreased from 2,014 or 8.1 per cent of the total.

CIVIL MATTERS

RECEIVED - 33,640 civil matters decreased 2,195 or 6.1 per cent from the 35,835 matters received in Fiscal Year 1966.

Tax Lien matters with 5,225 and Tort matters with 2,270 comprised 15.5 per cent and 6.7 per cent respectively of the total. Delegated General Claims matters amounted to 8,171 or 24.3 per cent of the total. 11,115 or 33.0 per cent of the total was in nine districts having totals ranging from 871 in Illinois Southern to 1,637 in Middle Florida.

TERMINATED - Civil matters terminated without reaching court dockets amounted to 6,717, a decrease of 17.1 or 1,390 from the fiscal year 1966 total of 8,107.

PENDING - 9,469 civil matters were pending as of June 30, 1967 as compared to 10,935 as of June 30, 1966. This is a decrease of 1,466 or 13.4 per cent.

MAN-HOURS

A total of 182,750 man-hours were spent in court during Fiscal Year 1967. Following is a breakdown of those hours.

Based on an average employment of 665.3 each Assistant United States Attorney averaged 27.5 hours per month in courtroom work during the fiscal year.

COLLECTIONS

Collections for Fiscal Year 1967 reached \$80,219,415, an increase of \$5,511,972 or 7.4 per cent over the \$74,707,443 collected in Fiscal Year 1966. This year's amount represents a return of \$3.79 for each dollar of the \$21,139,651 appropriated for United States Attorneys' Offices for the year ending June 30, 1967.

PERSONNEL

During the year United States Attorneys' employment averaged 1,727 employees, 385 employees were appointed and 346 were separated a net increase of 39 and 1,770 were on the rolls as of June 30, 1967. Cases handled per Assistant United States Attorney increased from 149.1 in Fiscal Year 1966 to 149.7 in the current year while cases terminated decreased from 93.7 to 90.5.

CASES PENDING IN UNITED STATES ATTORNEYS' OFFICES

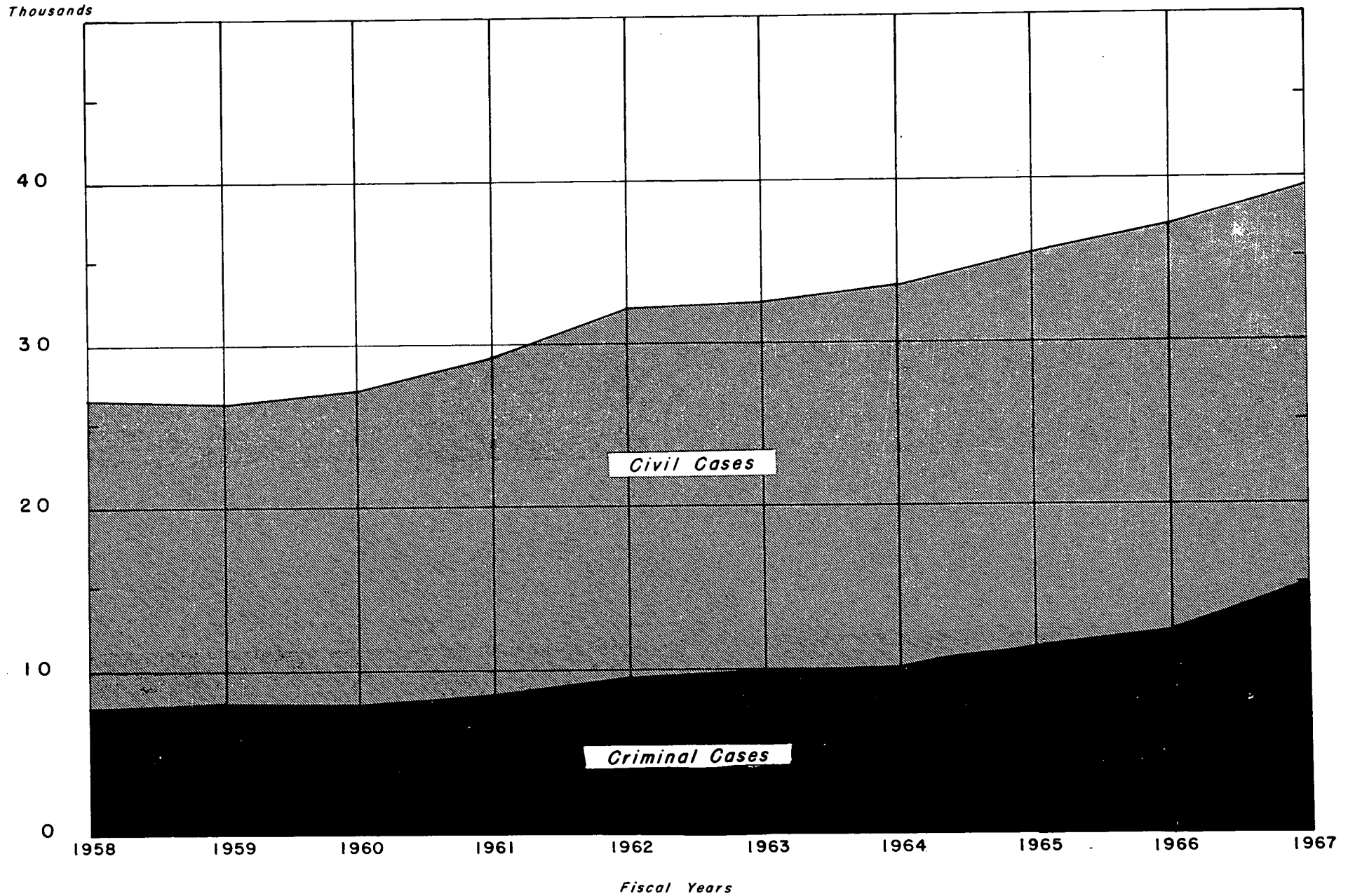

IN UNITED STATES ATTORNEYS' OFFICES

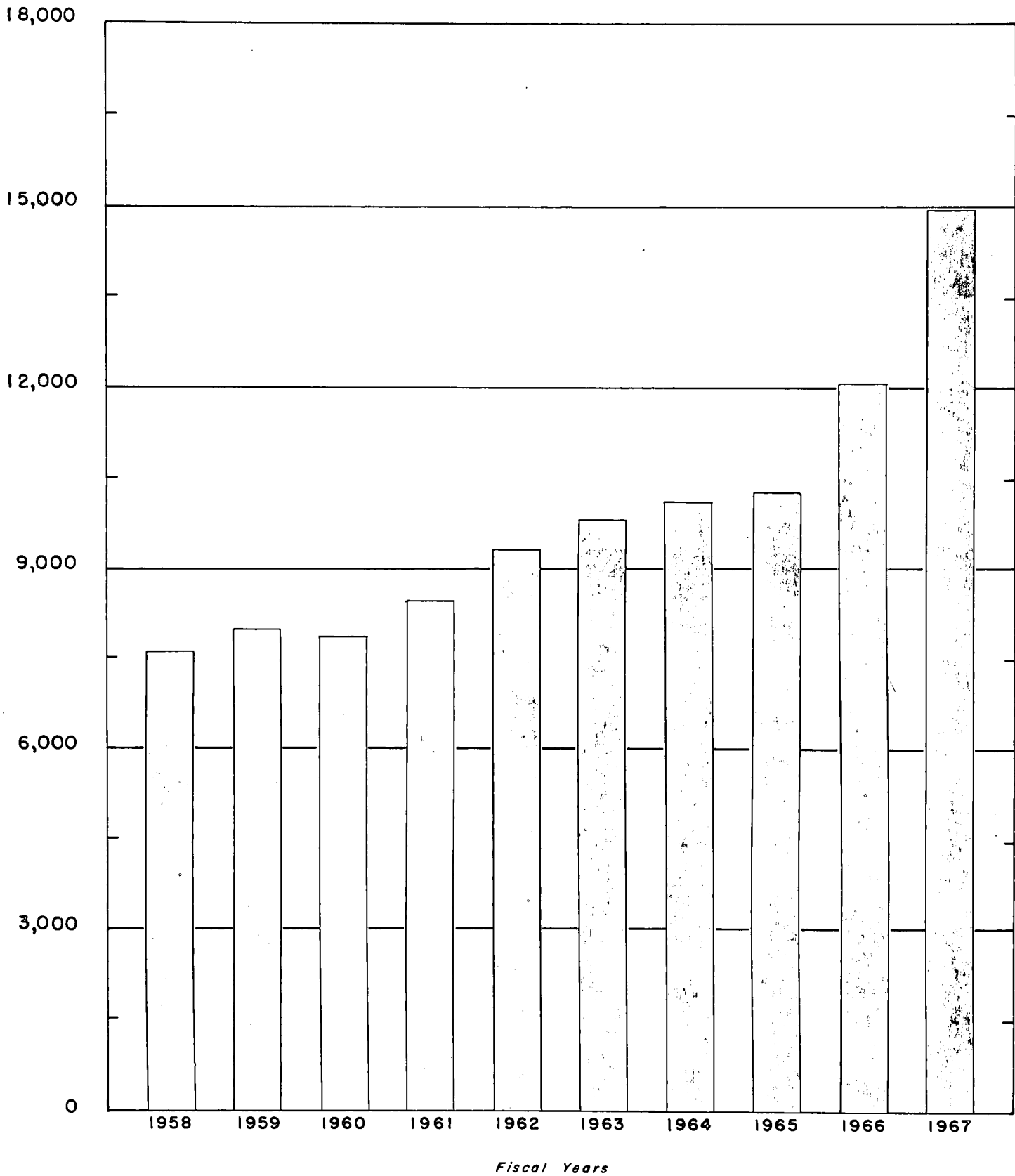

TOTAL 14,895 CASES

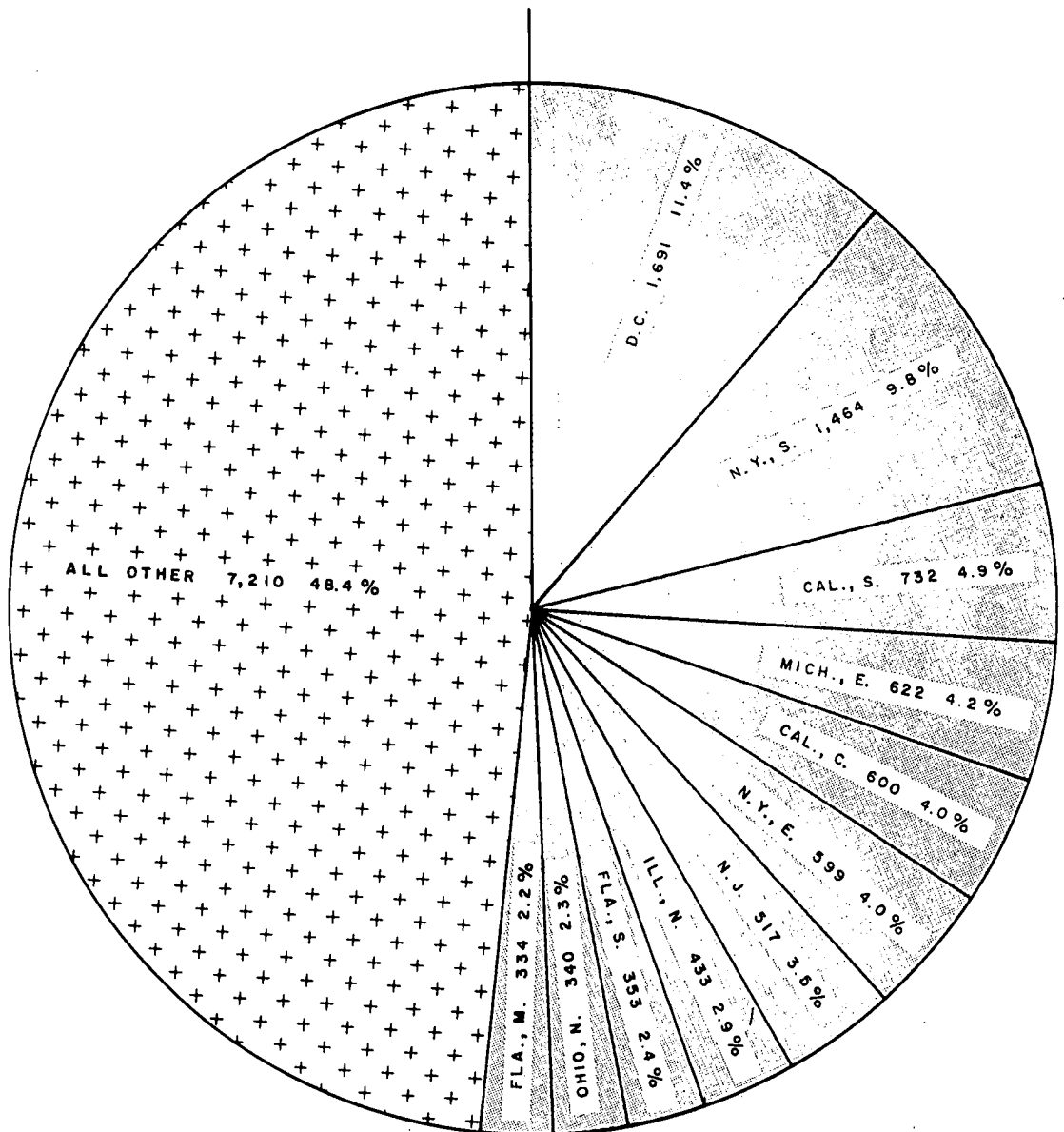

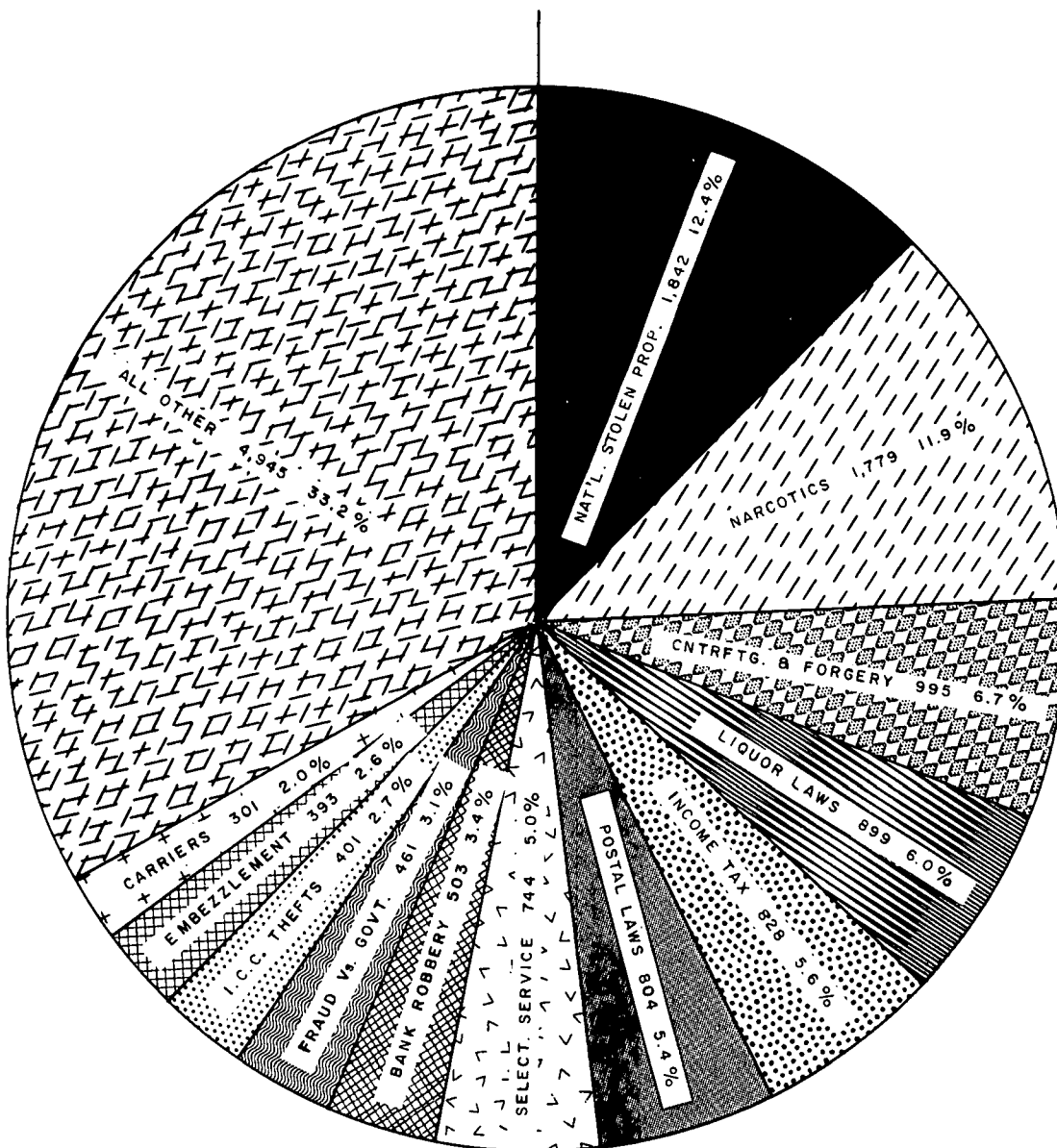

TOTAL 14,895 CASES

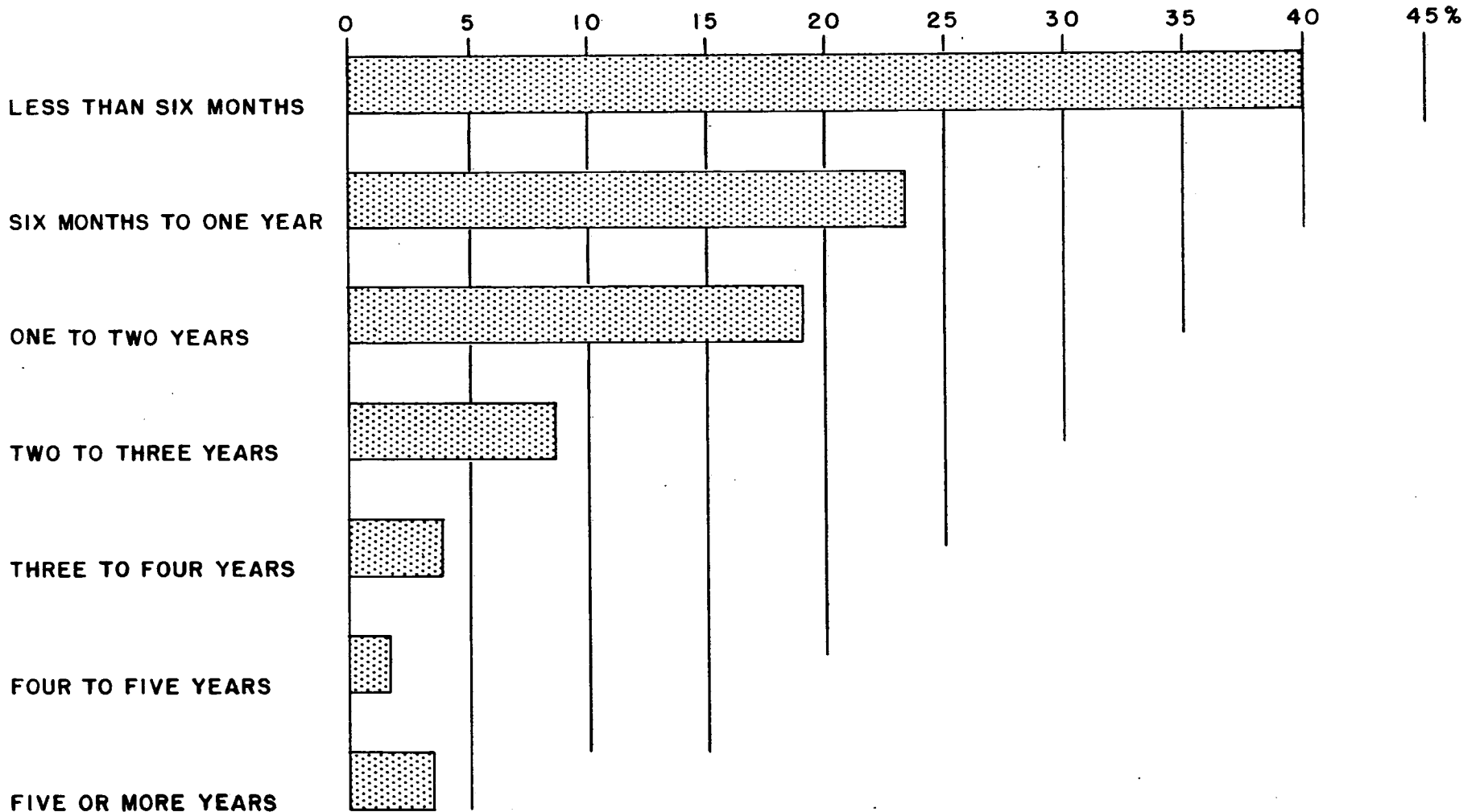


CHART NO. 6

IN UNITED STATES ATTORNEYS' OFFICES

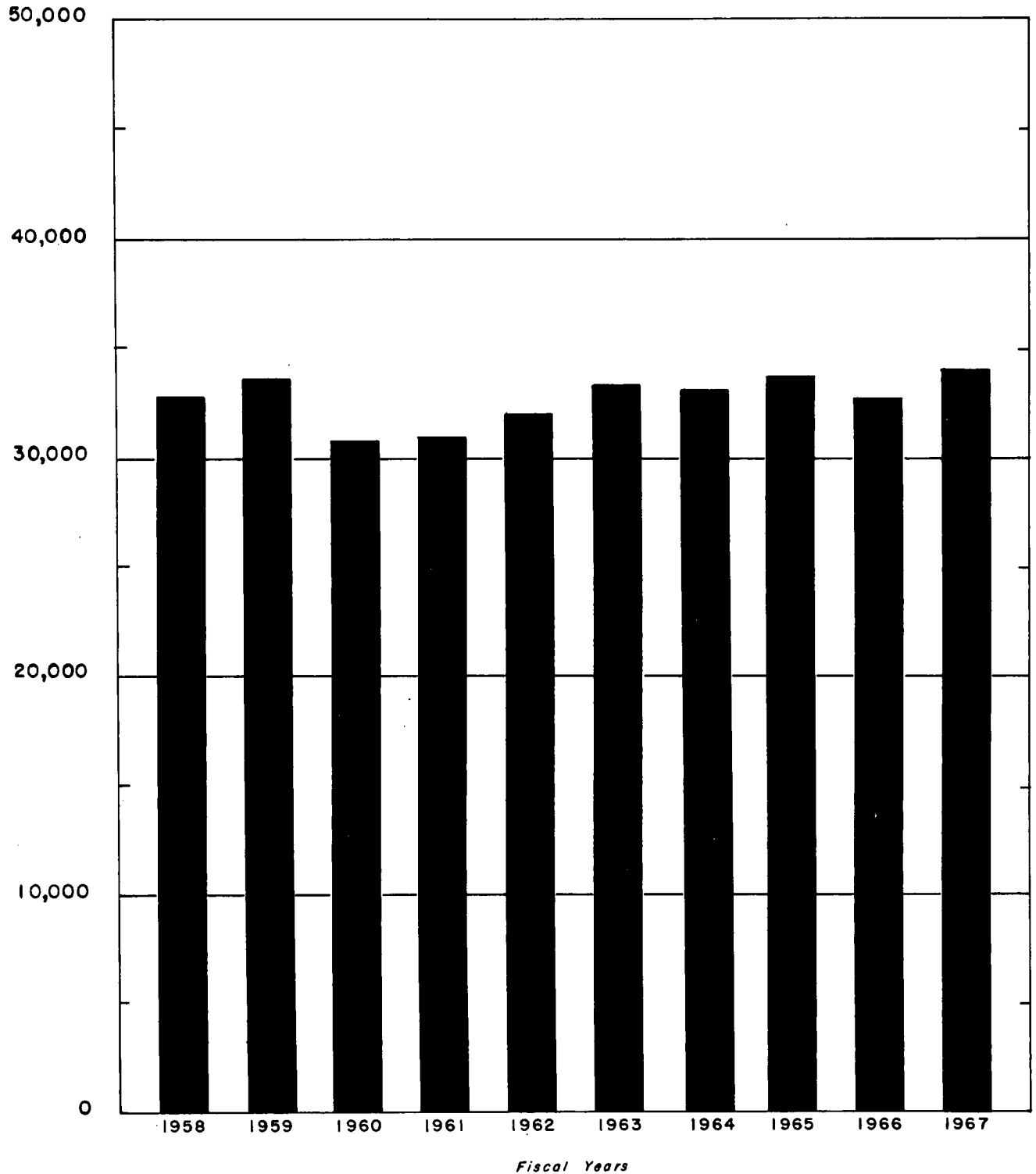

IN UNITED STATES ATTORNEYS' OFFICES

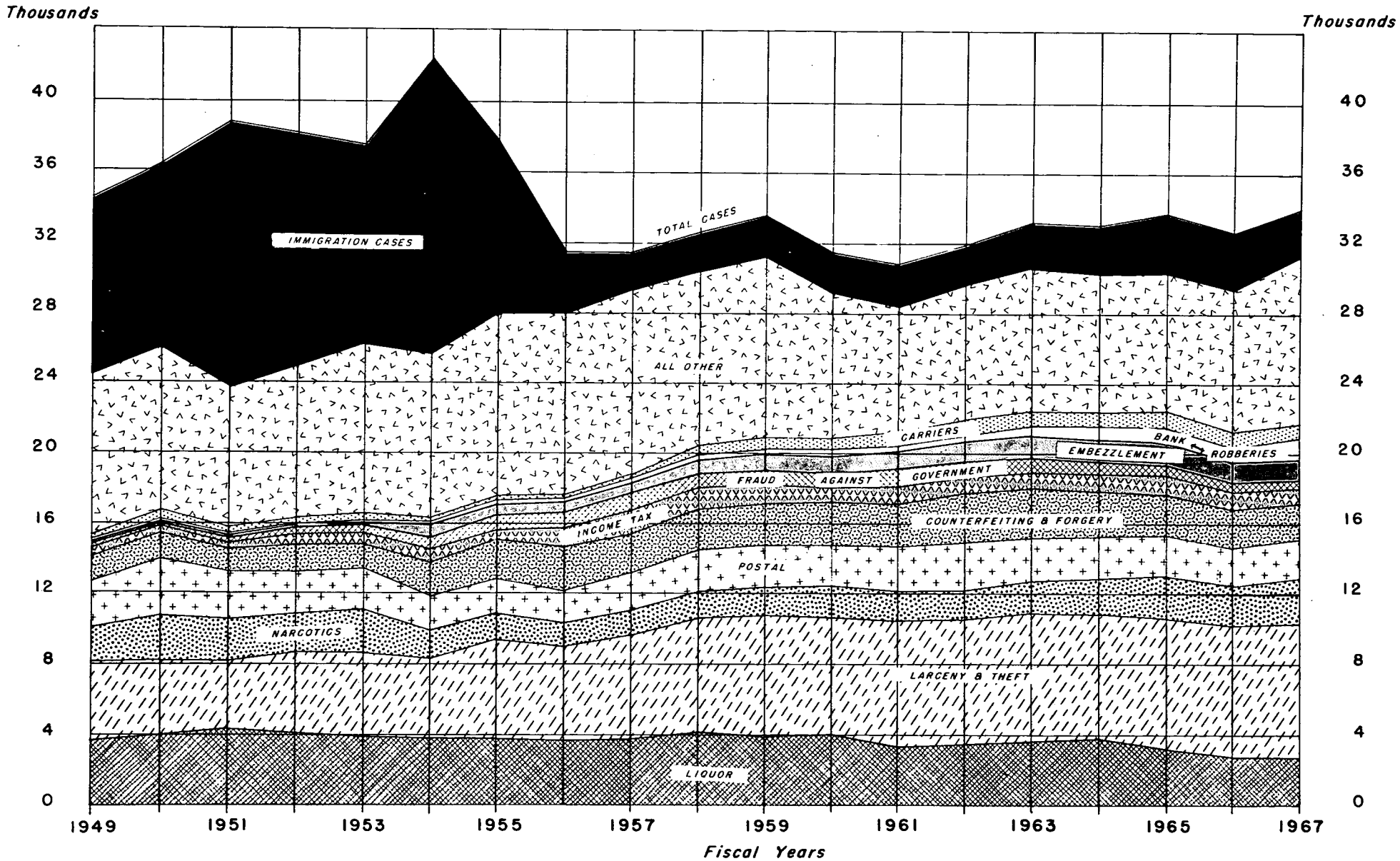

IN UNITED STATES ATTORNEYS' OFFICES

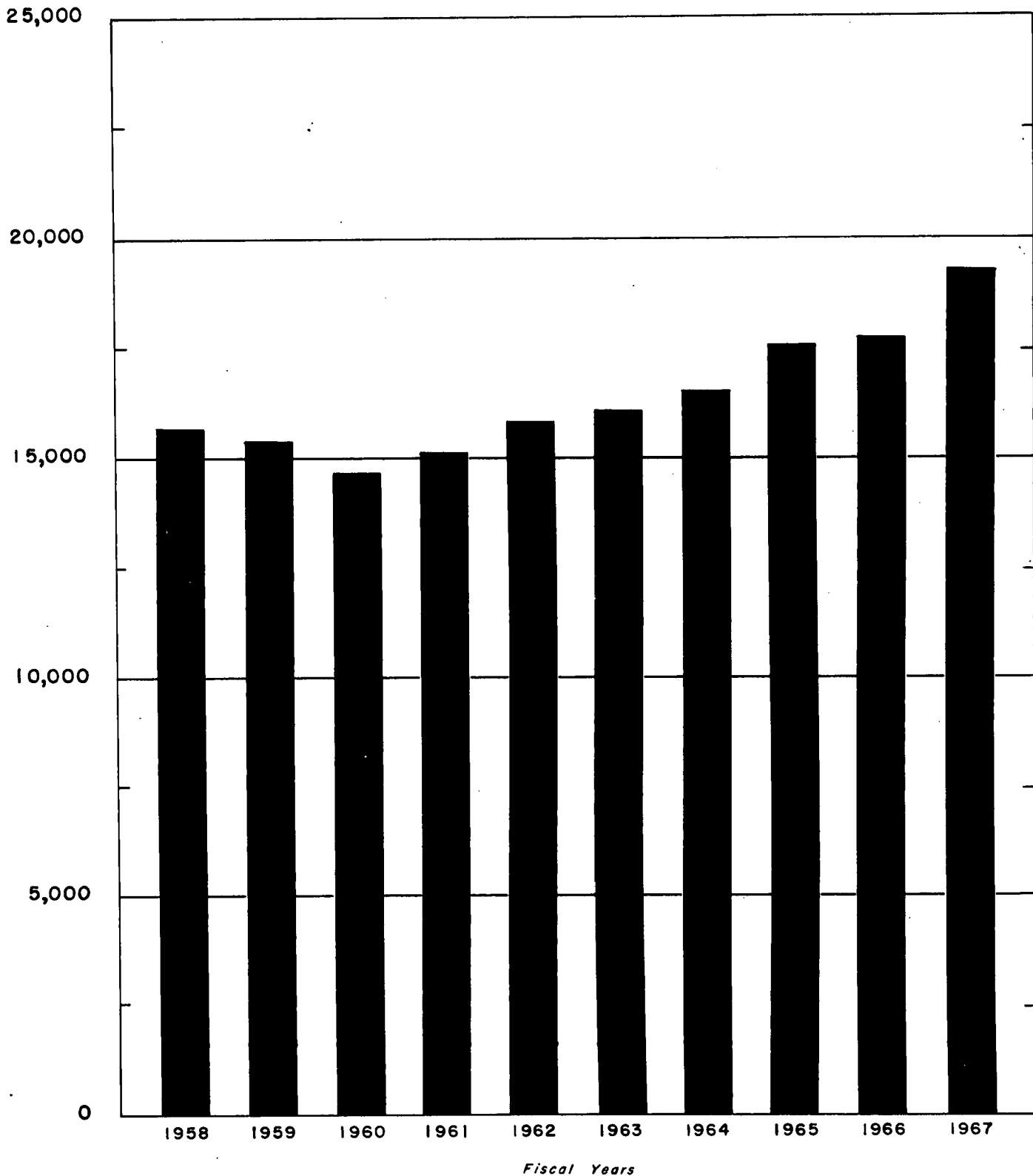

CRIMINAL CASES TERMINATED IN UNITED STATES ATTORNEYS' OFFICES

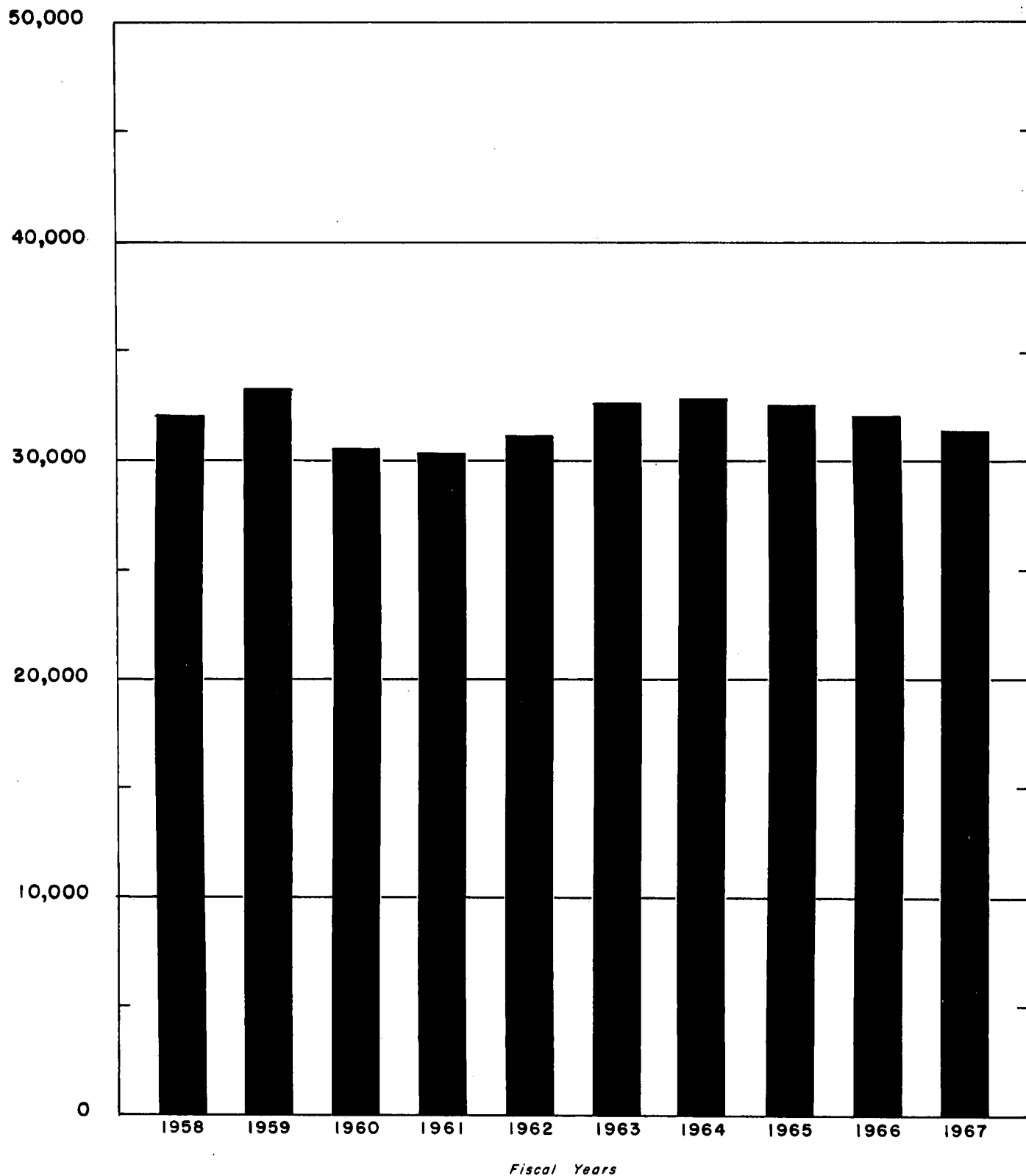

TRIALS IN CRIMINAL CASES IN UNITED STATES ATTORNEYS' OFFICES

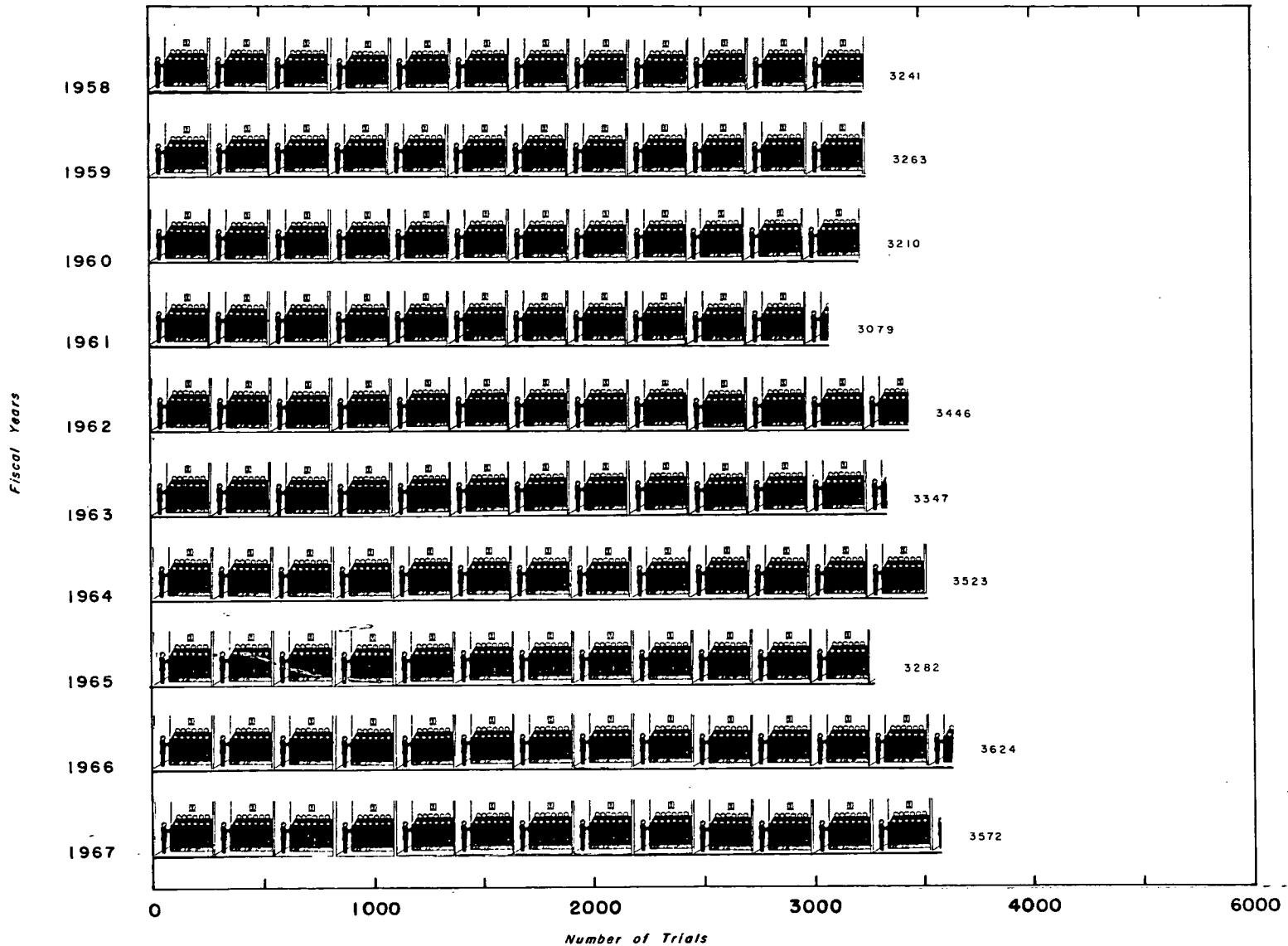

IN UNITED STATES ATTORNEYS' OFFICES

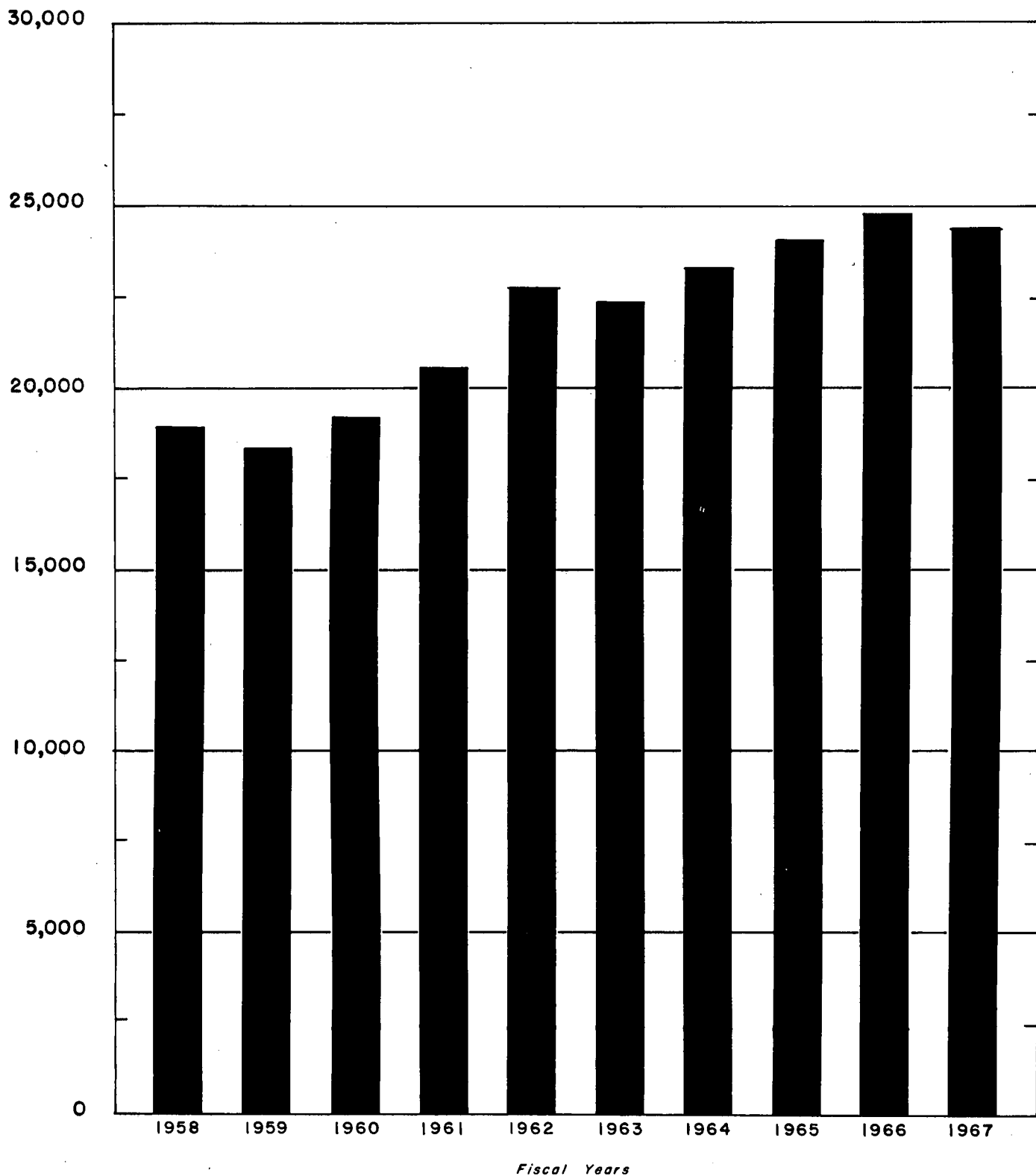

TOTAL 24,458 CASES

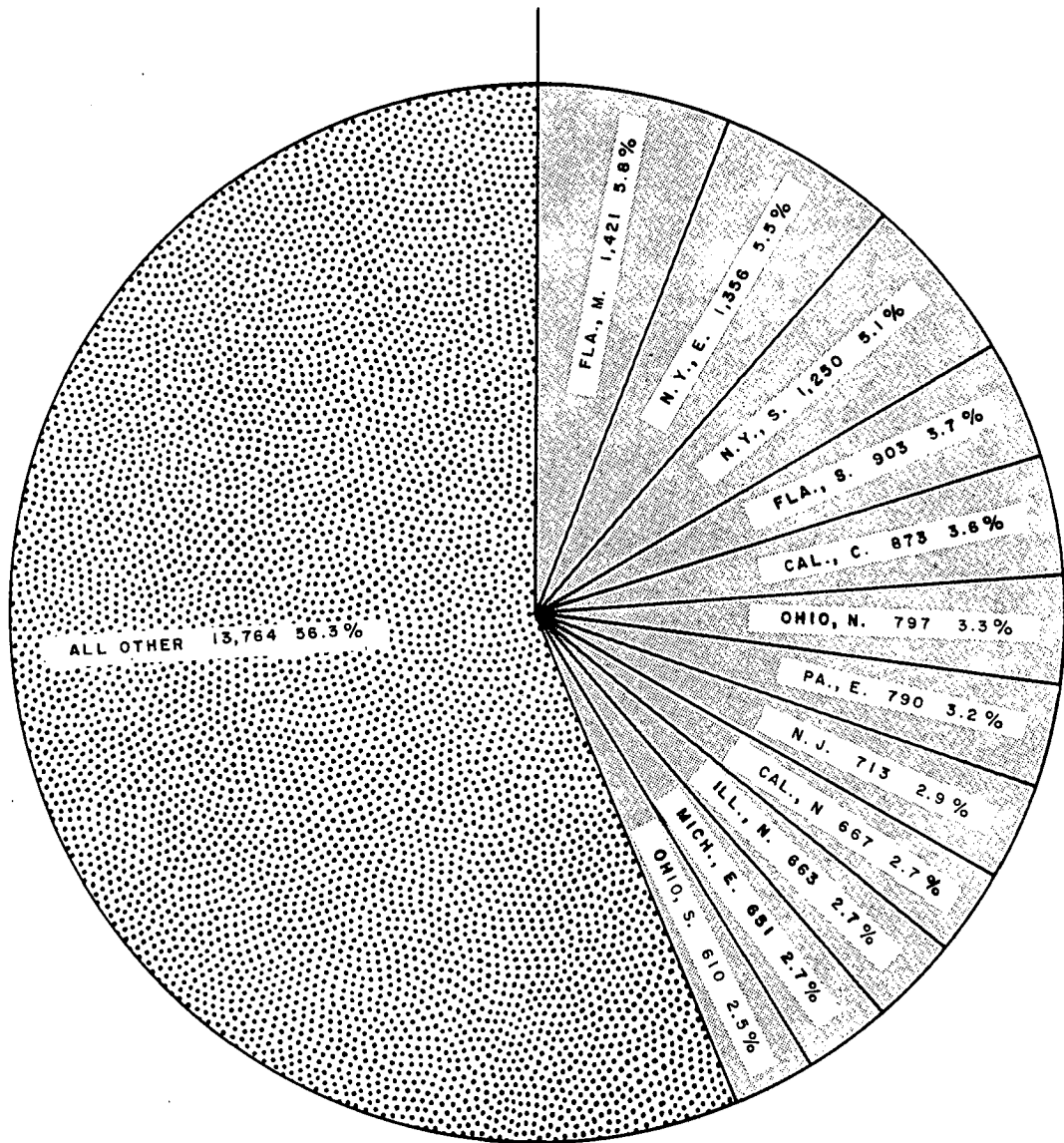
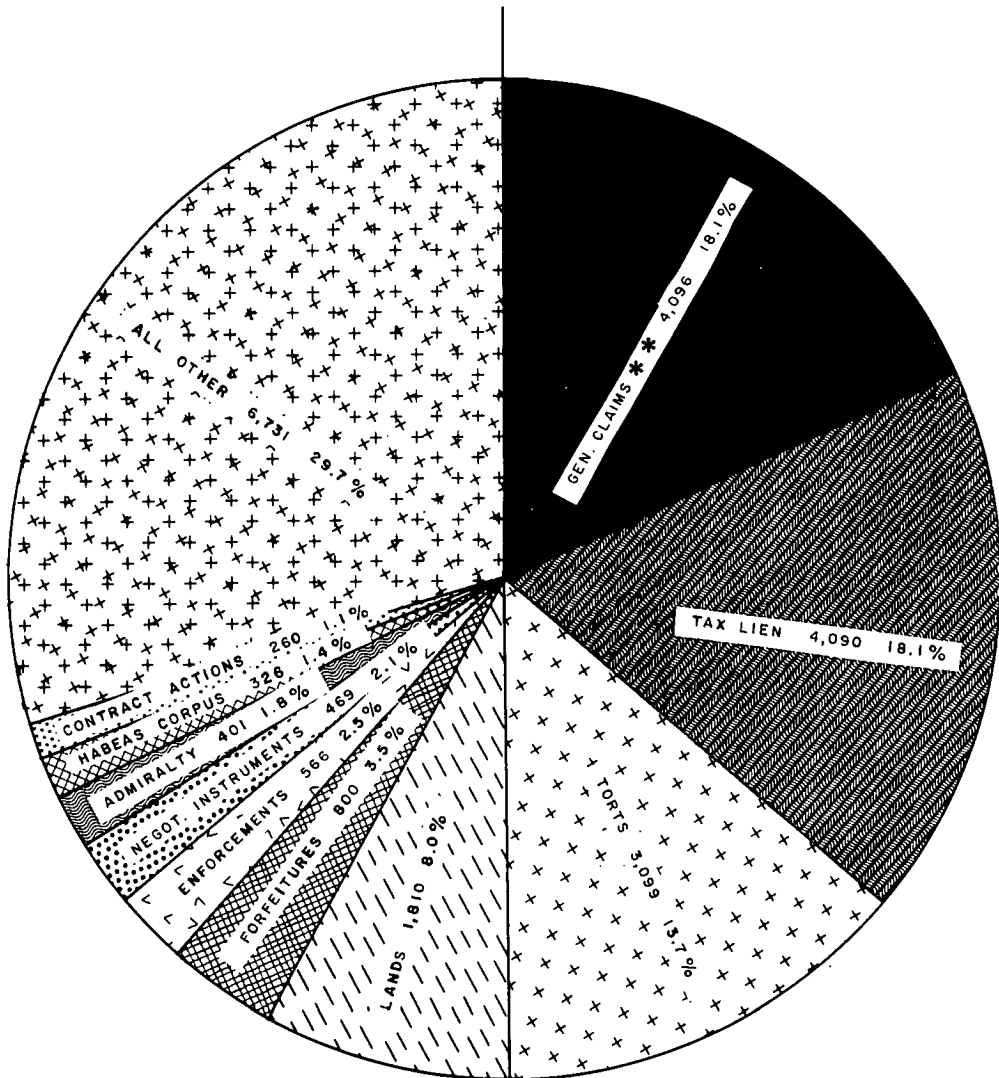


CHART NO. 13

TOTAL 22,646 CASES

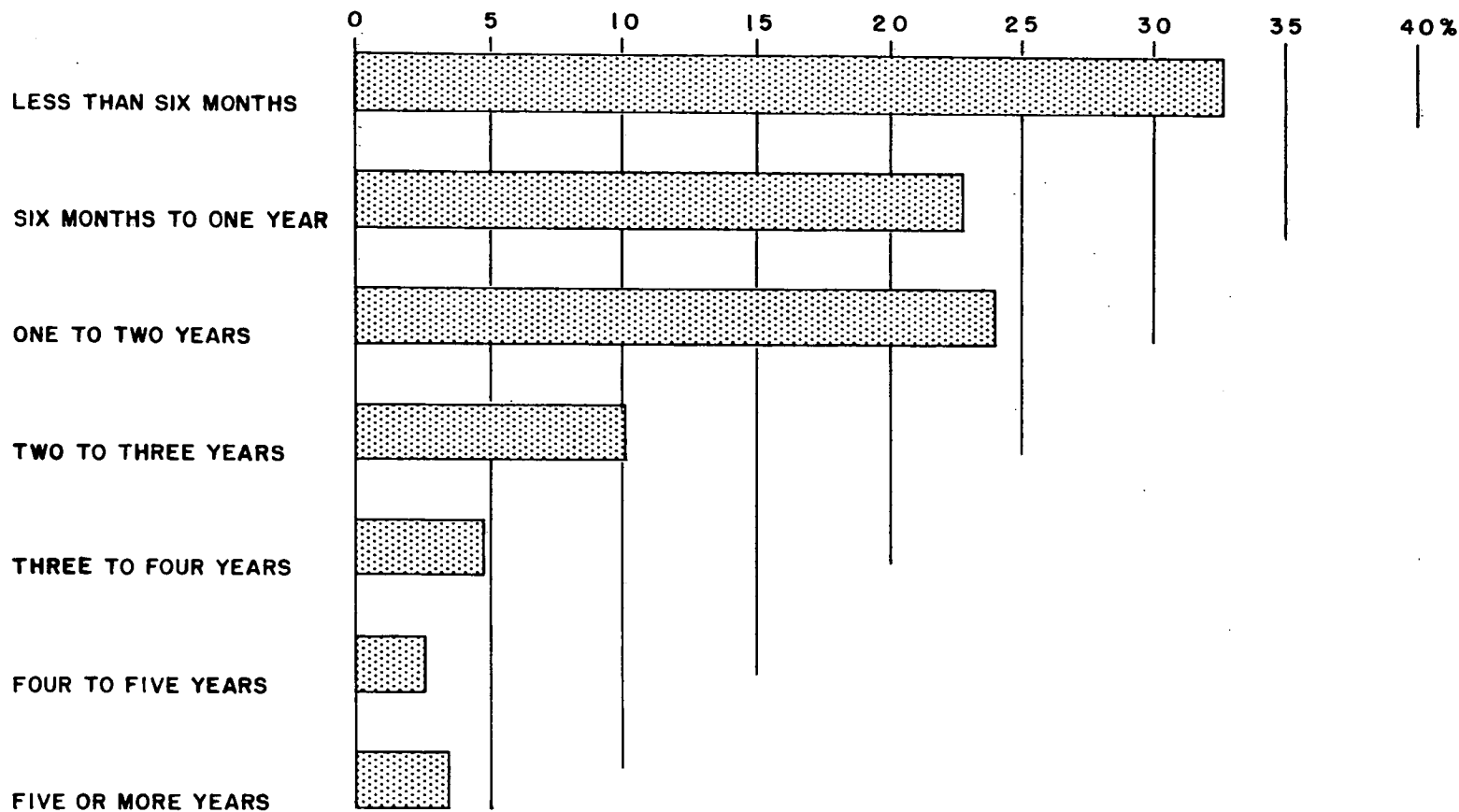

IN UNITED STATES ATTORNEYS' OFFICES

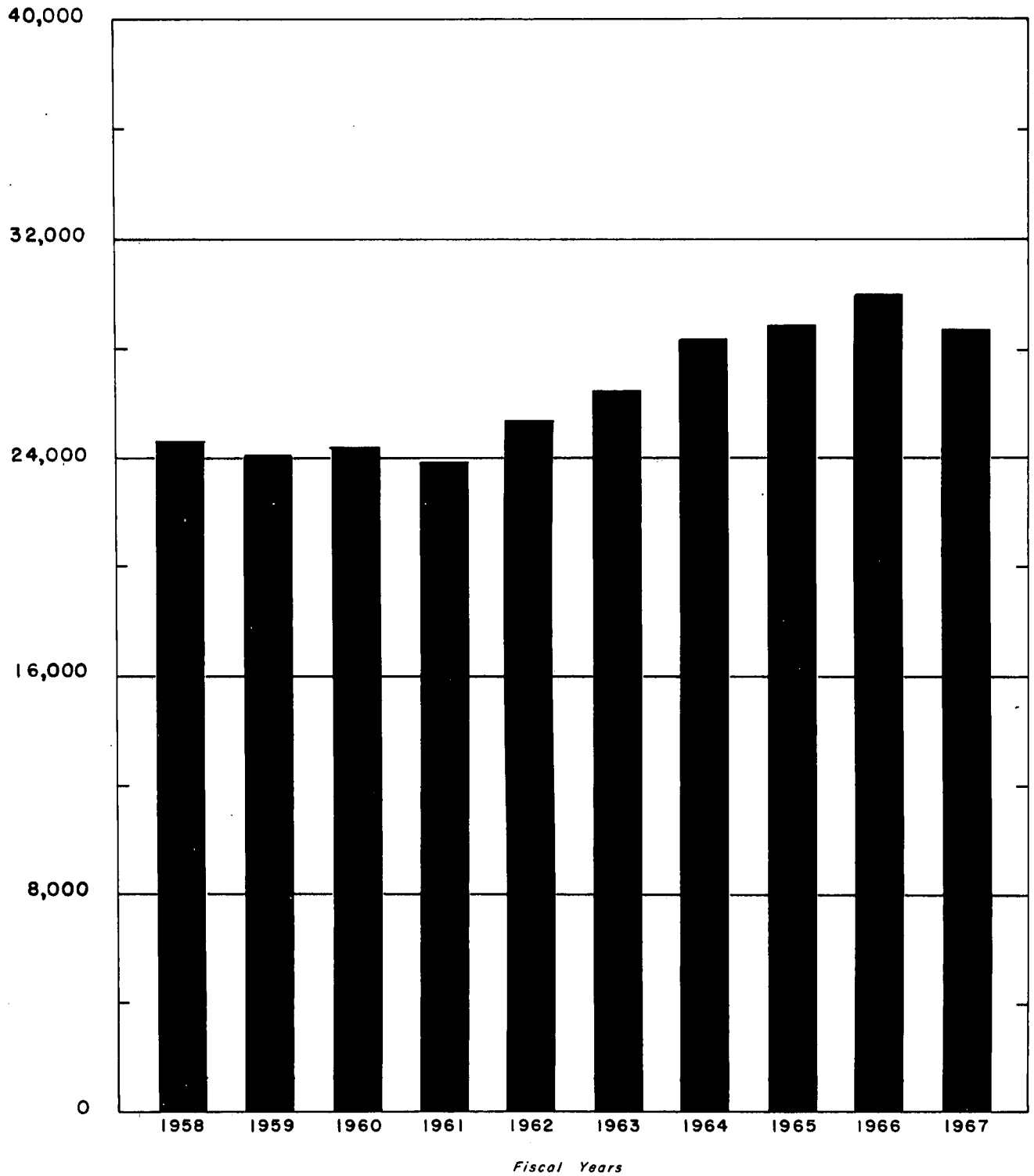


CHART NO. 16

IN UNITED STATES ATTORNEYS' OFFICES

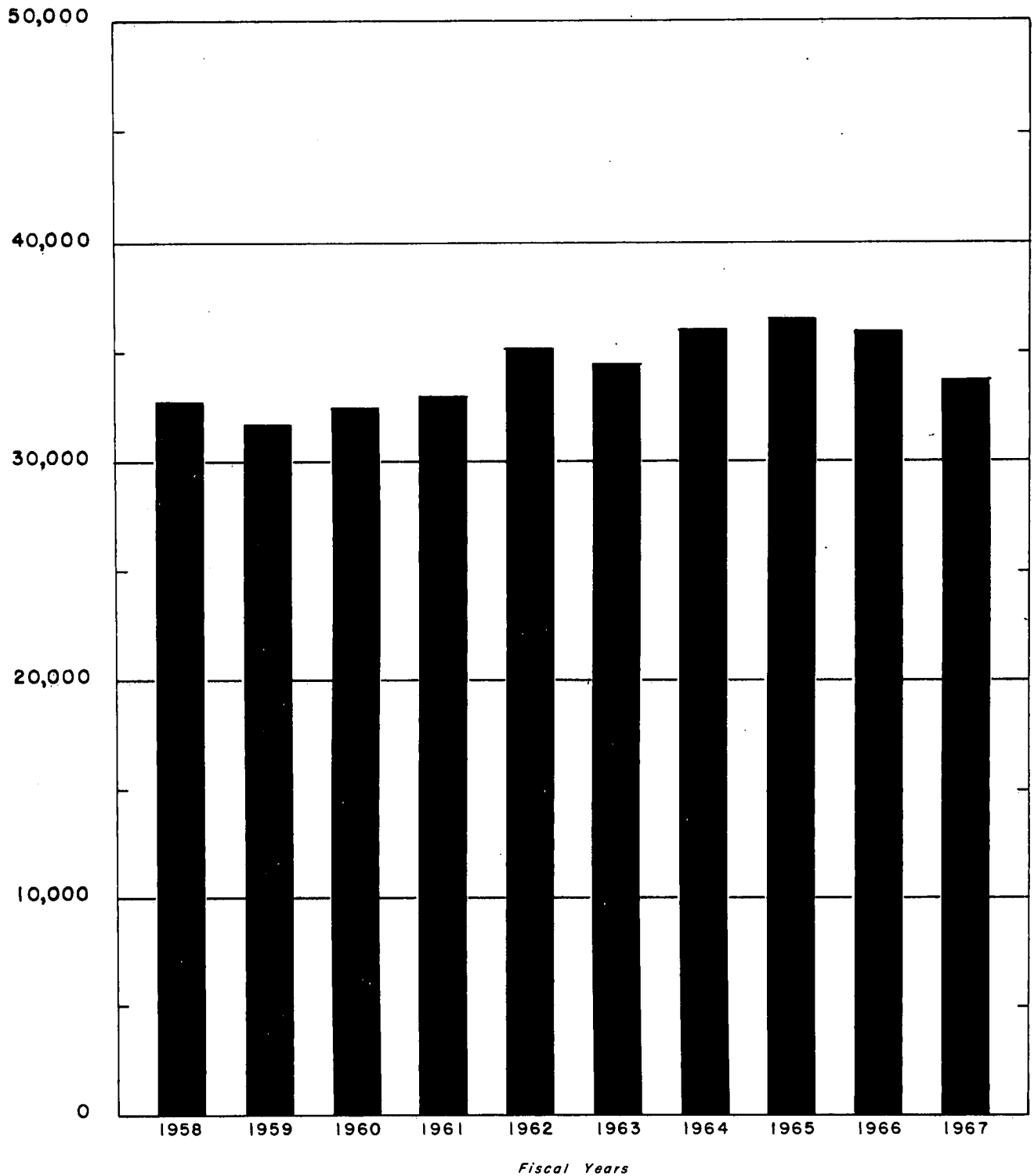


CHART NO. 17

IN UNITED STATES ATTORNEYS' OFFICES

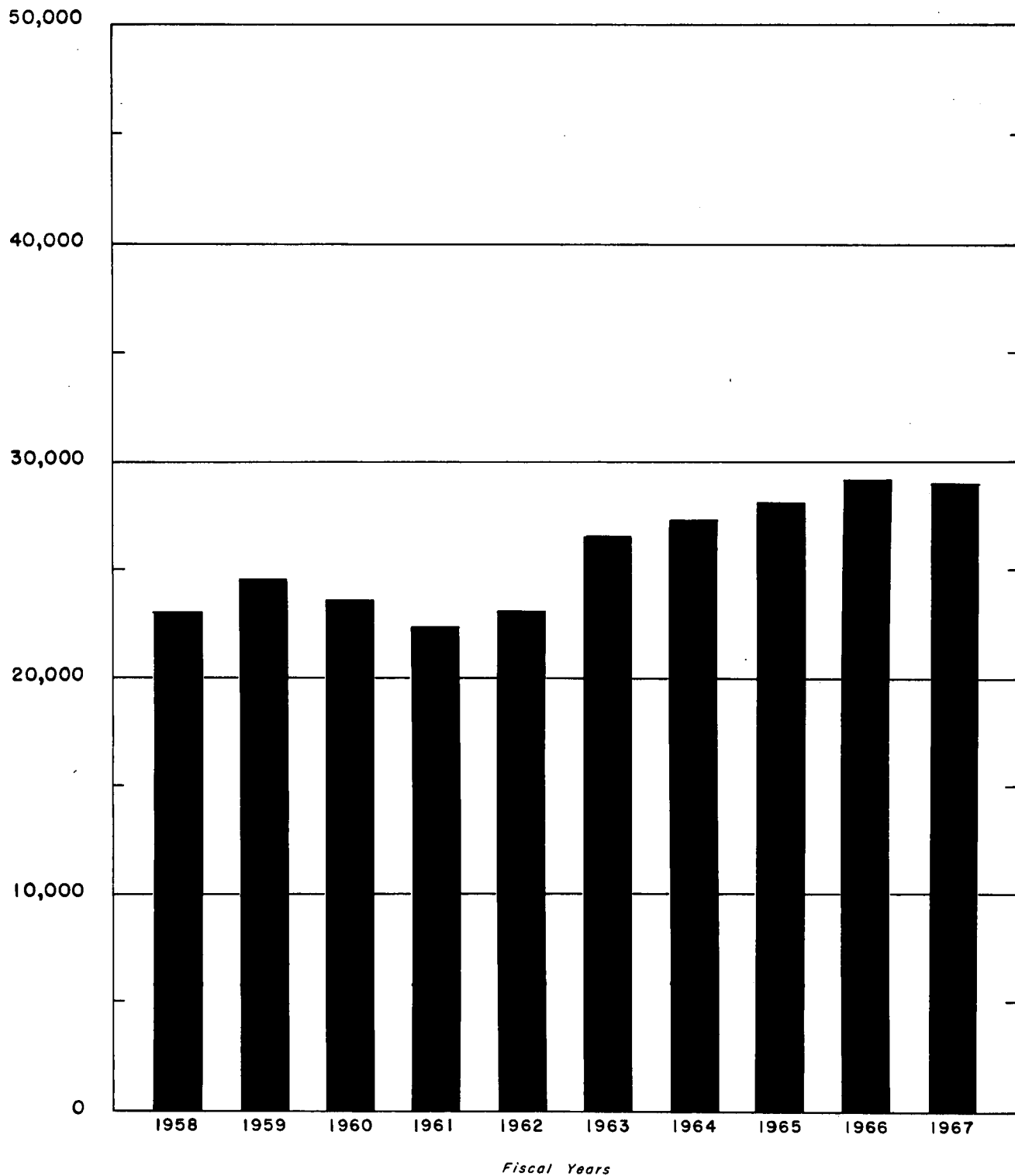

Millions of Dollars

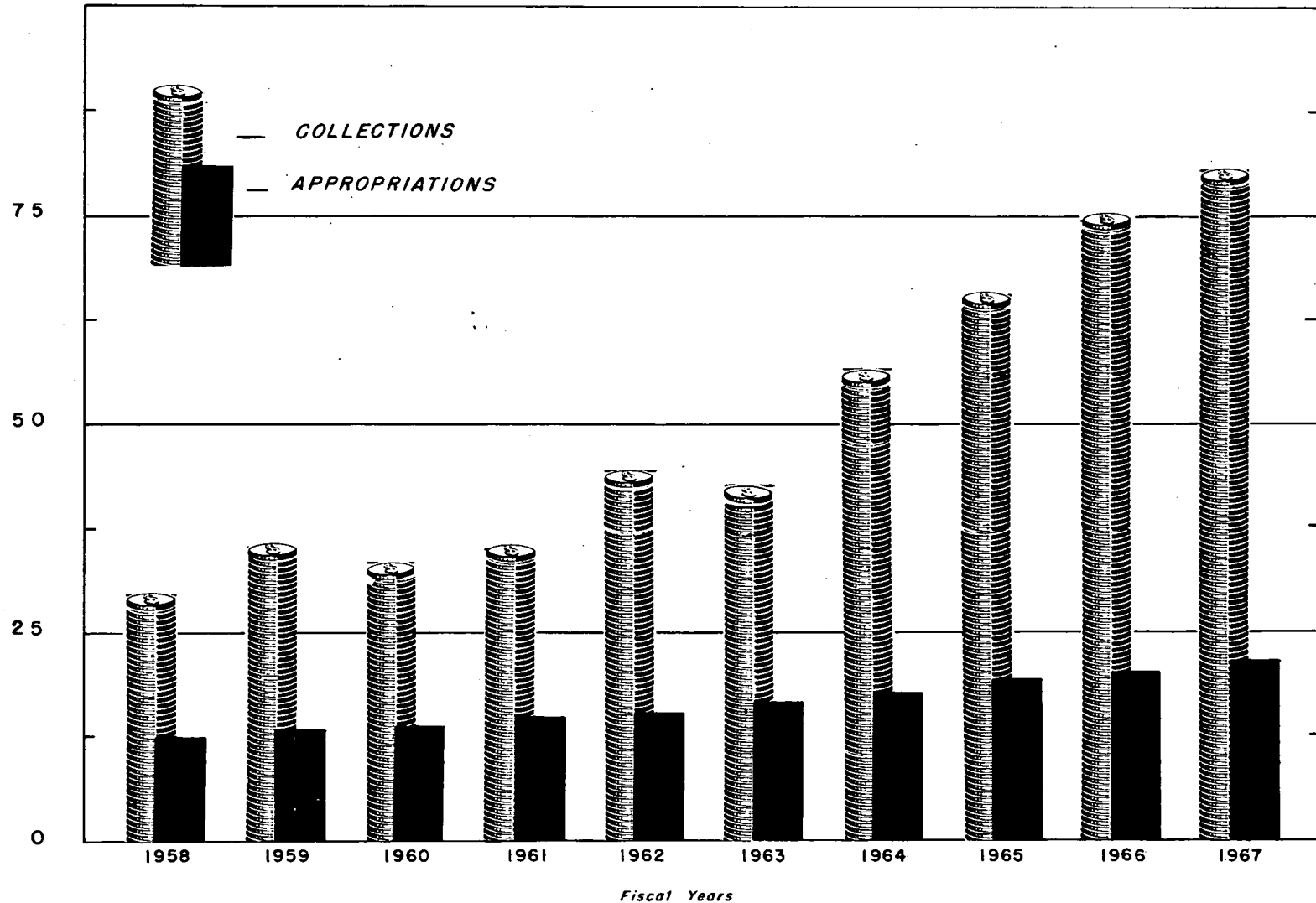

IN UNITED STATES ATTORNEYS' OFFICES

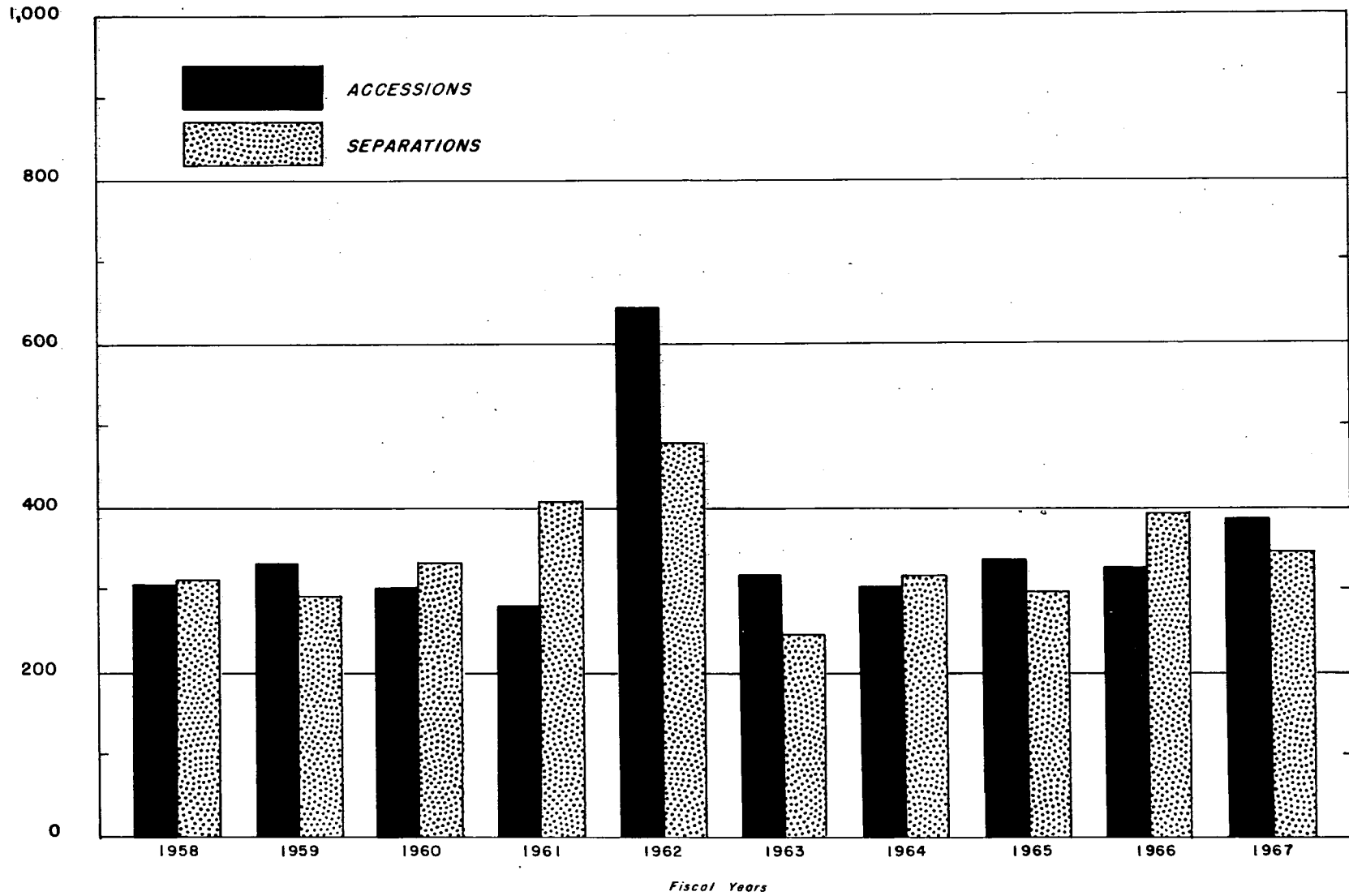
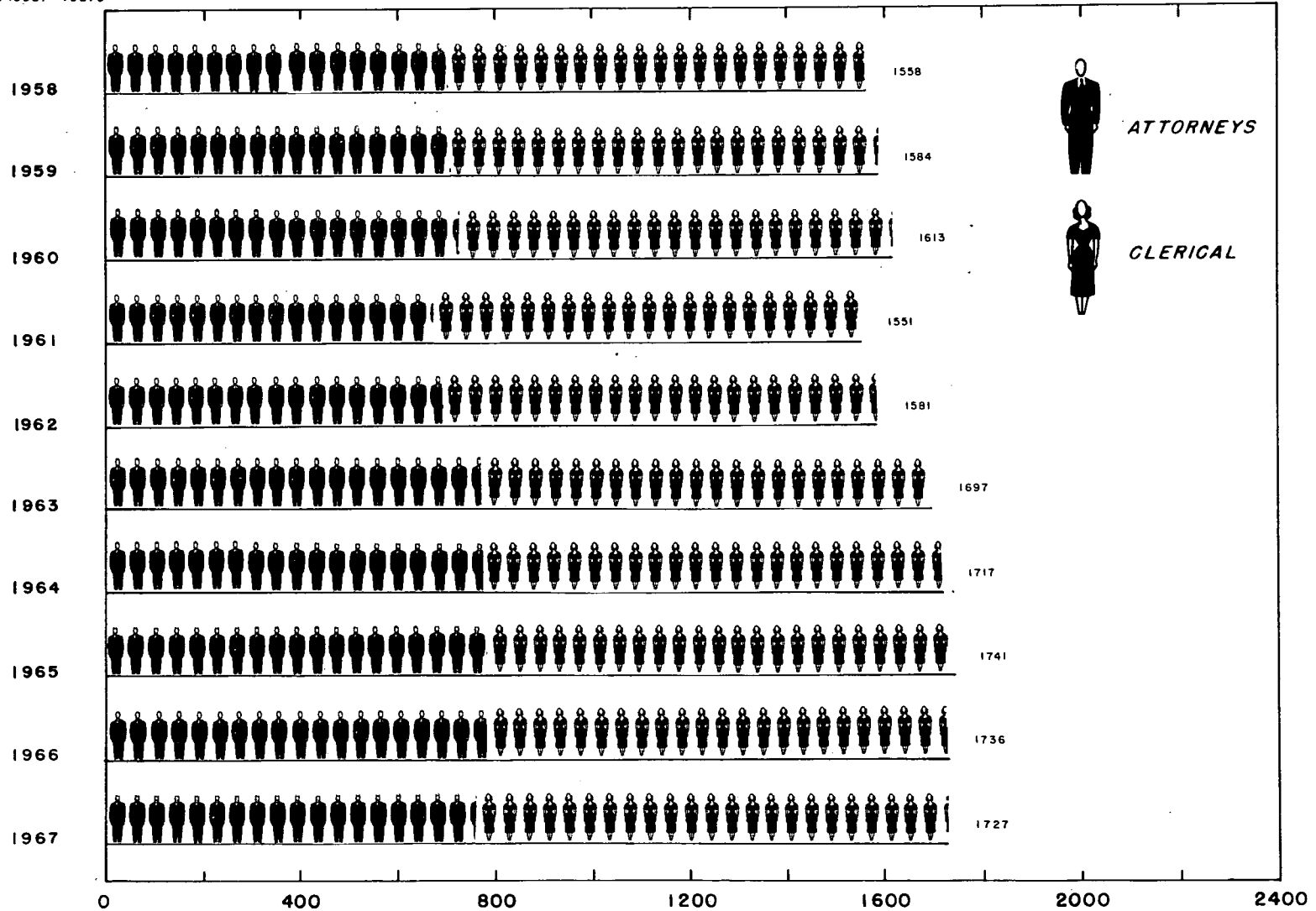


CHART NO. 20
