The above-named debtor(s) filed a voluntary petition for relief under Chapter 9 of the Bankruptcy Code. The Order for Relief under Chapter 9 was entered on January 11, 2017. Section 1102(b) of the Bankruptcy Code authorizes the United States Trustee to appoint an Official Committee of Unsecured Creditors ("Committee"), and the debtor's petition or other sources of information indicate that you may be eligible for appointment to the Committee in this case. The Committee represents the interests, and acts on behalf, of all unsecured creditors.

**If you wish to be considered for membership on the Committee**, please complete the enclosed Questionnaire and return it to the Office of the United States Trustee **no later than 12:00 p.m. on January 27, 2017, via fax to (415) 705-3379 or by email to [ankey.to@usdoj.gov](mailto:ankey.to@usdoj.gov)**. Return of the questionnaire, however, does not guaranty appointment to the Committee, only that you will be considered. If you do not wish to serve on the Committee, you do not need to return the form or attend the meeting.

If you wish to be considered for Committee membership but are unable to attend, you should immediately notify the Office of the United States Trustee. If you do not attend the meeting and do not affirmatively indicate your willingness to serve, you will not be considered. If you send an individual to represent you at the meeting, that representative must present your written proxy authorizing him or her to act on your behalf.

The purpose of the meeting will be for the United States Trustee to obtain, if necessary, additional information that might be helpful in forming the Committee. This meeting will not be a general information session about the Chapter 9 case.
