We have worked with the Bankruptcy Court to develop an ECF entry entitled:

## Bankruptcy Events --> Trustee/US Trustee - Report of Returned Funds

As you can see, the entry is listed in the <u>Trustee/US Trustee menu</u>. As stated in the previous email, this form would be completed by you and submitted to the applicable reviewer along with form 2, proposed distribution, and bank statements from the time the TFR was submitted forward. The reviewer would review the report and notify you by email once their review is complete. <u>You</u> would then file the report along with form 2.

Please begin implementing this procedure immediately. I have contacted the major software vendors (BMS, Epiq, Trustee Solutions) and asked them to include this form in your software package.
